## INTERNET WEBCAST - DISTANCE LEARNING OPPORTUNITY Patriot Act – Bank Secrecy Update



For many credit unions, BSA Compliance is still a common weakness. If there has not been sufficient reason to develop an applicable compliance program in the past, then four recent events, September 11 and related OFAC developments, passage of the Patriot Act, amendment of the Bank Secrecy Act along with regulatory reviews beginning in October 2003, recent revisions to SAR and CTR, and recent emphasis on regulatory enforcement with multi-million dollar fines should give all credit unions pause to be concerned. On February 11, noted compliance attorney R. Todd Sherpy will be addressing these issues during our live interactive web cast.

PATRIOT ACT – BANK SECRECY UPDATE
