The Parents, individually and as the parents of the Student, do further agree to indemnify and defend University Prep against any and all claims for property damage or personal injuries alleged to have been caused by the Student which are related in any way to his/her driving his/her personal family vehicle on the Athletics Activities or are related in any way to the fact that his/her personal family vehicle has been taken of the Athletics Activity. For purposes of this Release, Hold Harmless, and Indemnification Agreement, University Prep includes all employees, agents, and trustees, and other representatives (past, present, or future) of University Prep.
