This three hour interactive workshop will cover (but not limited to) Legal Issues (student fees, contracting, bidding, student confidentiality, drug testing, fundraising,) Risk Management (travel, on and off campus activities, parent volunteers, fieldtrips,) and Civil Rights (free speech, right to privacy, student handbooks, due process, equal rights, Supreme Court decisions concerning student rights.) Our panel of experts will help you to discover best practices for dealing with many of these important issues. **Pre-registration ends Friday, February 10, 2012.** After Feb 10, you must wait and register onsite with onsite prices. Do not mail any payment after Feb 11th; bring with you to onsite registration.

**Cancellation Policy:** Cancellations received in writing postmarked by February 10, 2012 will be refunded less a \$35 administrative fee. No refunds after February 10, 2012.

**Substitution/Transfer Policy:** Transfers made in writing prior to February 10, 2012 will be assessed a \$35 administrative fee to transfer a registration to another individual. If you are transferring a member to a non-member attendee etc., the difference in registration fees will be charged as well. All name badges are prepared the week of February 13, 2012. Therefore, any transfer requests after February 10, 2012 should be brought to the registration desk onsite where a \$50 fee will be collected and the transfer will be made.

Only registered participants with their name badges are admitted to the exhibit area and convention activities.

This is a professional, adult conference - no children will be admitted to sessions, events, or exhibit hall.
