Information Alert

The Walgreens Corporation has changed its corporate policy and is now choosing to sell alcohol in its stores. As a result, Indiana has been inundated with license requests for Walgreen stores. Statewide, 102 license requests have been filed; 29 in Marion County alone 28% of the permits requested are for Indianapolis. The type of permit requested in Marion County would allow for the sale of beer, wine and hard liquor. Marion County already has 169 package liquor stores; 202 beer and wine dealer permits for convenience, drug, and grocery stores; and 105 liquor dealer permits for pharmacies, either in stand-alone drug stores or as part of a grocery store.

All of the Walgreen permit requests have a local hearing date of June 7, 2010. Community groups need to be prepared to voice any concerns at that time.

Please note: As of May 14, eighteen locations have received their zoning affidavit from the Metropolitan Board of Zoning. Those who have received the affidavit have been highlighted in blue. Four locations are under consideration (pink) and five (white) will need to request a variance in order to apply for an alcoholic beverage permit. All have been slated to be heard on June 7th. Community members will need to notify the local board of problems with the applications especially if they are not appropriately zoned.

On Drug Free Marion County's website, you can find a Remonstrations Manual that explains the local hearing process and how concerned citizens and groups can remonstrate against a license request.
