Being a caregiver is not an easy job. As leaders, we often struggle to find ways to improve caregiver sensitivity, particularly in nursing homes. By immersing ourselves in "someone else's shoes" we catch a glimpse and can apply that empathy with a focus on person-centered care. While creating and expanding this program, we realized it goes "hand in hand" with prevention of abuse and caring for the resident with dementia. Implementing CMS Hand in Hand modules as an integral component of new staff orientation, CNA class, and training for existing staff can and has made such a positive impact in the attitudes and actions of caregivers.
