**T-Star's "EnergySaver" swimming pool and spa covers are
NOT SAFETY COVERS!**

T-Star's "EnergySaver" swimming pool and spa cover system was specifically designed to save money on loss on heat, chemicals, and water due to evaporation and NOT as safety covers.

T-Star's "EnergySaver" swimming pool and spa cover system should be used only in a controlled and supervised environment that meet and satisfy the following guidelines:

- Swimming pool and/or spa must be enclosed and restricted from the surrounding environment by an approved fencing system or enclosure.
- Swimming pool and/or spa must be under supervision of management personnel or other person(s) of responsibility who has sole access to the pool and/or spa area when it is not open for use. The pool and/or spa area must be securely locked to prevent any usage of the pool and/or spa when covers are in place on the pool and/or spa.
- The pool and/or spa may not be reopened for use until all pool and/or spa covers are removed completely from the pool and/or spa and stored safely in its proper storage reels or its equivalent by trained personnel.

In compliance with ASTM labeling standard F-1346, warning labels (see sample below) are securely attached and strategically placed on every "EnergySaver" swimming pool covers produced by T-Star Enterprises, Inc.

DO NOT remove warning labels! DO NOT pull on warning labels! Call your local sales representative or call us directly @ 510-635-2736 when an old, torn warning label is needed to be replaced. *Important:* be sure to deploy covers with warning labels facing up and place covers so that warning labels are situated as close to the deck as possible to noticed, seen, and read. DO NOT cover or hide warning labels.

3. Do NOT swim or play in pool and/or spa that is completely or partially covered, or as covers are being deployed or reeled-in from the pool and/or spa. Do NOT attempt to swim or play under covers.
