**8. ADOPTION OF INTERIM BUDGET**

Section 242(1) of the Municipal Government Act states each Council must adopt an operating budget for each calendar year. (2) A council may adopt an interim operating budget for part of a calendar year. (3) An interim operating budget for a part of a calendar year ceases to have any effect when the operating budget for that calendar year is adopted.

**Res. 252-15** **MOTION:** Moved by Councillor Bigelow that Council approve to adopt the Village of Cremona 2015 Operating budget as the Village of Cremona 2016 Interim Operating Budget until such as time as the 2016 Village of Cremona Operating budget is passed.
