Steve Martin, Franklin County Ohio's 51st Sheriff, was sworn into office on June 2, 2011. As Franklin County Sheriff, he oversaw a \$94,000,000 budget and nearly 1000 employees. In the eighteen years prior, Steve was the Chief Deputy of Investigations, commanding the Detective Bureau, Special Investigations Unit, Fugitive Squad, Civil Division and Emergency Management. Additionally, he administered the operations of SWAT, Hostage Negotiators, Bomb Squad, Internal Affairs, Photo Lab, Property Room, and the Records Bureau.

Mike Miller, *Kegler Brown Hill and Ritter*, has decades of experience in criminal proceedings, and practices exclusively in the firm's Criminal Law area. He has been with the firm since 1997. An experienced attorney who was Franklin County's elected prosecuting attorney for 17 years, he has been involved in more than 150 jury trials, including some 52 death cases. He handles felony and misdemeanor cases throughout Ohio in local, state and federal courts.

Harry W. Trombitas is the System Vice President, Security Operations at OhioHealth; the Director of the Police Executive Leadership College (PELC) for the Ohio Association of the Chiefs of Police and a Sociology Lecturer at The Ohio State University. He was a Police Officer/Detective at Northwestern University in Evanston, Illinois – '78-'79 and a Supervisor/Director of Public Safety at Creighton University, Omaha, Nebraska – '79-'83. He became an FBI Agent in 1983. Assigned to the Omaha, St. Louis, and New York Divisions before transfer to the Columbus Office in December 1991. Worked predominantly violent crime including bank robbery, kidnapping, serial murder, crimes against children, criminal profiling, threat assessment, and served as the FBI's spokesperson since 2003. Retired from the FBI on April 30, 2012. Mr. Trombitas received his B.A. Criminal Justice from The Ohio State University and his Master's Degree in Counseling/Psychology from Creighton University

9:00am Case Two - Charles McCoy, Jr.

Charles McCoy, Jr., terrorized the City of Columbus in 2003 when he shot and killed a grandmother out for a day of shopping with her best friend while both were traveling in a vehicle on the south end of I-270. The random shootings continued for several months while investigators covered over 5,700 tips and cleared 1,400 people mentioned as possible suspects. Although luckily no one else was injured, the impact of the shootings was felt throughout central Ohio and beyond. The case was in the national spotlight as it came on the heels of the DC Sniper shooting investigation in Washington DC, Virginia, and Maryland.

10:45am Case One - Thomas Lee Dillon

Thomas Lee Dillon hunted humans in Southeastern Ohio from 1989 – 1992, killing five outdoorsmen with a high powered rifle during that period and severely injuring another. Dillon was also responsible for numerous animal killings, including cows and horses, as well as committing over 150 arsons. This one man crime wave was eventually brought to justice by a task force made up of local detectives and prosecutors, along with the FBI.
