## ADOPTION OF ORDINANCE NO. 10-4 (UNCODIFIED)– Amendment of Contract with California Public Employees Retirement System (CalPERS)

Motion was made by Allen and seconded by Peterson to adopt Ordinance No. 10-4, entitled "AN ORDINANCE (UNCODIFIED) OF THE CITY COUNCIL OF THE CITY OF CONCORD AUTHORIZING AN AMENDMENT TO THE CONTRACT BETWEEN THE CITY OF CONCORD AND THE BOARD OF ADMINISTRATION OF THE CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM TO PROVIDE THE "2.0% AT AGE 55" BENEFIT FORMULA FOR MISCELLANEOUS MEMBERS ENTERING MEMBERSHIP FOR THE FIRST TIME IN THE MISCELLANEOUS CLASSIFICATION AFTER THE EFFECTIVE DATE OF THIS AMENDMENT TO THE CONTRACT" to add Section 20475, creating a new tier in the retirement program for Miscellaneous New Hire Employees Only with a 2% @ 55 formula. This Ordinance amendment was introduced on September 28, 2010. Motion passed by the following vote of the Council:

# AWARD OF CONTRACT TO McNABB CONSTRUCTION, INC. – Project No. 2177, Bocce Courts at Baldwin Park

He concluded his comments by stating that General Fund money was being loaned to initiate the project, but would be paid back. Motion was made by Bjerke and seconded by Hoffmeister to award a construction contract in the total amount of \$366,450 for the base bid and alternate bid to McNabb Construction, Inc. of Lafayette for Project No. 2177, Bocce Courts at Baldwin Park. # CONTINUATION OF PUBLIC HEARING – Proposed Redevelopment Plan

The City Council confirmed the staff recommendation to continue the consideration of the proposed Redevelopment Plan (the "Redevelopment Plan") for the Concord Community Reuse Redevelopment Project (the "Project") and consideration of all evidence and testimony for or against the approval and adoption of the proposed Redevelopment Plan to a date uncertain with proper notification when rescheduled.

#### CANCELLATION OF PUBLIC HEARING – Appeal by Wieslaw J. Pisula

This Public Hearing had been previously continued from the meetings of September 14, 2010 and October 12, 2010 at the request of Mr. Pisula and/or his attorney Roni Rothholz. The appeal submitted by Wieslaw J. Pisula over the Concord Police Department's denial of an application for a Taxi Driver Permit was withdrawn by the Appellant, cancelling the public hearing.

#### CONTINUATION OF PUBLIC HEARING – General Plan Amendment

The consideration of a proposed General Plan Amendment to update the City's Housing Element which includes a revised statement of goals, policies, quantified objectives, land inventory, and a schedule of programs for the preservation, improvement and development of housing on a Citywide basis, was continued to November 16, 2010 at the recommendation of staff who was awaiting additional input from outside agencies.
