

DESIGN AWARDS

GENERAL INFORMATION

All entries must be received in electronic format. Upon receipt of the entry form and fee, the entrant will be provided an official PowerPoint template with step by step instructions for use in the electronic submission. The template has been designed so that text and images can be inserted into a preset layout. To maintain consistency and fairness, no modifications to the layout will be accepted.

The electronic format facilitates a submission in which all images support the program statement. Each visual should have a purpose as it relates to the larger idea. The photos should contain compelling pieces of information to make the statement visually understood. Be sure to label drawings clearly and to include a north arrow.

Within each square, images may be layered or placed side-by-side. The area beneath the slide entry number, located in the right-hand side column of the image square, is available for you to place statements to further support the design concept. Consider the impact the image will make when projected onto a large screen.

EXCELLENCE IN ARCHITECTURE

This award intends to encourage excellence in architecture, elevate public consciousness of good design and recognize those architects whose work enriches our built environment. All entries must be architectural projects designed by licensed architects with offices in Miami-Dade County, Monroe County and/or the Caribbean. Projects may be located anywhere in the world and must have been completed by January 1, 2013.

The program is open to architectural projects of all sizes and classifications. It is not necessary for the entrant to assign a classification to the project for this award. Eligible projects include single buildings, groups of buildings, parks and plazas, historic preservation, additions, remodeling, adaptive re-use, urban design and sustainable design.

EXCELLENCE IN INTERIOR DESIGN

This award intends to encourage excellence in interior design, elevate public consciousness of good design and recognize those interior designers and architects whose work enhances the interior built environment.

All entries must be designed by licensed interior designers or licensed architects with offices in Miami-Dade County, Monroe County and/or the Caribbean.

Projects submitted may be located anywhere in the world and they must have been completed by January 1, 2013. The program is open to interior design projects of all sizes and types.

SUBMISSION GUIDELINES

PROJECT ENTRIES

Project information: Include program statement, program summary, area, cost per square foot, construction cost and date of completion, project code number and classification.

Plans and Drawings: Include site plan, floor plan(s) or details describing special features, construction systems, "before" views etc.

Photography/Images: Include exterior views showing major elevations, interior views (one or more) other views or details describing special features, nighttime images, construction systems, "before" views etc.

Identification Information: The name and location of project, owner/client, architect(s) of record name and address, project team, landscape architect, interior designers, consultants, general contractor, photographer and project code number will need to be provided for each entry at the time each entry is ready to be uploaded. This information will not be seen by the jury, rather it will be used to identify winners and for the Design Awards presentation.

ENTRY PROCESS (3 steps)

1) Submit entry form, fee and classification by Friday, August 16, 2013. Entry forms can be sent via email with credit card payment information or by mail with a check or credit card payment information to the AIA Miami office.

2) Upon receipt of entry form and fees, you will receive a code number and a PowerPoint template for each entry via email. AIA Miami will then also provide complete submission guidelines and instructions for how and when to upload each submission. No other form of entry will be accepted.

3) A separate PowerPoint for each entry, clearly titled with the project name, code number and award classification must be uploaded as per the provided instructions. Each entry must be uploaded individually. The deadline to upload all entries is Friday, September 13, 2013. Upon Jury review, finalists will be notified. The number of awards in each category will be at the discretion of the jury.

EXCELLENCE IN LANDSCAPE ARCHITECTURE

This award intends to encourage excellence in landscape architecture, elevate public consciousness of good design and recognize those landscape architects and architects whose work enhances the built environment.

All entries must be designed by licensed landscape architects or licensed architects with offices in Miami-Dade County, Monroe County and/or the Caribbean. Projects submitted may be located anywhere in the world and they must have been completed by January 1, 2013. The program is open to landscape architecture projects of all sizes and types.

UNBUILT DESIGN

This award intends to encourage excellence in design with attention focused on the design process. Its purpose is to recognize outstanding examples of recent, commissioned architectural designs not yet built or complete, as well as to identify non-commissioned projects that exemplify excellence in design while exploring the nature and science of the profession. Construction must not be substantially complete prior to December 31, 2013.

FIRM OF THE YEAR AWARD

Entries must represent the firm's last ten years of architectural work as well as statements of the firm's participation in educational programs, involvement in community service, service to the profession and the AIA. Entries may include any material which best describes the firm's achievements and should include a minimum of one image, with a brief narrative, per project with a minimum of five projects.

Images of the winning projects will be exhibited at the Celebrate Architecture + Design Awards Gala on Friday, November 1, 2013 at the Miami Center for Architecture & Design in Downtown Miami.

PROFESSIONAL HONOR AWARDS

These awards will also be presented at the Celebrate Architecture + Design Gala on November 1, 2013. Look for the Call for Nominations via email and on the AIA Miami website by early September 2013.
