

REQUEST FOR QUOTE
Masonry Repair Work
Newstead Town Hall

The Town of Newstead is seeking written Requests for Quotes to perform masonry restoration work on the Town Hall building located at 5 Clarence Center Rd, Akron, NY. Only the original existing portion of the building is being considered for this bid. An addition was put on the rear of the building in 2011 and that section is excluded from this quote request. One quote should be submitted for the project on form provided, with the costs for each of the 5 categories of work below separately called out and must include all necessary material costs and labor to perform the following work:

1. Repointing of existing split ribbed concrete block walls on the south elevation and front sections of the east and west elevations.
2. Removal of sealant on existing masonry control joints and replacement of sealant.
3. Caulking any necessary joints along the exterior roof line.
4. Silicone sealants removed and replaced around all windows and door frames on south elevation and front sections of the east and west elevations.
5. New bent .060 thick aluminum covers with color matched to frames installed on window sill ledges, to be adhered to the substrate using urethane adhesive.
6. Water repellant sealer of all masonry on south elevation and front east and west elevations.

The pebbled roof overhang panels on the south and east elevations are not a part of this request for quotes and should not be considered in the written quotes. Bidders should examine the site and acquaint themselves with the building to best account for delivering and handling of equipment and materials to the site and determining measures required to protect existing work, public and personnel from construction operations. All work shall be conducted in such a manner that the building can carry on ordinary functions and accessibility by the public without interferences. Ingress and egress must be maintained at all times. Any necessary barriers, signs or danger signs must be accounted for by the contractor in the bid.

Those interested in submitting a written quote must do so no later than May 8, 2015 at 1:00pm to the Newstead Town Clerk, Dawn Izydorczak, 5 Clarence Center Rd, Akron, NY 14001. If you have any questions regarding this bid please contact Town Clerk Dawn Izydorczak at 542-4573. Attention is called to General Municipal Law, which requires a Certificate of Non-Collusion and Waiver of Immunity for each proposal. Copies of such certificates are part of the Proposal Form and, unless complied with, this proposal will not be accepted.

Once the quotes are received they will be reviewed by the Town Board. The Town of Newstead reserves the right to reject any and all quotes and to waive any informality. All quotes shall be made in full on forms furnished and shall be enclosed in a sealed envelope marked "Town of Newstead Masonry Work Quote". No quote may be withdrawn before the expiration of 45 calendar days after the actual date of the opening thereof.
