CONDITIONS:

- 1. If the aircraft has been registered in another state, a Certificate should be furnished from the competent authorities in the state of such registration that the registration is cancelled.
- 2. Fifteen working days should be allowed from receipt of registration application for the DGCA to process the application. An aircraft type/model which is not currently certified in the State of Kuwait may require special investigation with a consequential increwse in time required.
- 3. The making of false statement for the purpose of procuring the issue of a certificate of registration is an offence under the Act 60 of 1960. The Directorate General of Civil Aviation may, in any case in which they think it is desirable, require the applicant for a certificate of registrate to furnish such evidence as they may desire and to make and subscribe a statuatory declaration as to the truth of the facts set out in the application.
- 4. Aircraft may be allocated any three letter sequence which is either not used, or has not previously been used, except for certain reserved groups of letters. Owners should note that the registration marks cannot be transferred from one aircraft to another. For details please contact the Aviation Safety Department.
