The meeting was called to order at 6:40 p.m. by Carlos Canino, Board President.

AGENDA ITEM 1: Approval of Minutes for Sep. 23, 2014

Upon motion by Margot Moss, seconded by Jeff Crockett, the Sep. 23, 2014 Board Minutes were unanimously approved.

AGENDA ITEM 2: Committee Reports

Kevin Jacobs gave reports for the Audit & Finance Committee as well as the Investment Committee. He advised that Goldman Sachs was selected as LSGMI's Investment Advisor. He explained the process used in selecting Goldman Sachs and the determining factors. Ratification of Goldman Sachs as investment advisor for LSGMI will be made at the Jan. 20th, 2015 board meeting.

Upon motion made by Barnaby Min, seconded by Darrell Payne, the new Certificates of Deposits were unanimously approved.

Oxana Cardini went over the budget comparison and explained the variances. She explained that operating funds have been supplemented with fundraising revenue to cover the operating deficit.

Oxana also reminded the Board that the Tax Return Form 990 was provided to all Board members via email on Oct. 31 to prior to filing. She noted that the County requires that this be reflected in the Board minutes.

Marcia Cypen reported for the Real Estate Committee that we are considering two options: purchasing the building located at 4343 Flagler St., and leasing space at 79th St. & Biscayne for 10 years. We are open to other options as well.

Tiffani Lee reported on the Community Support Committee's efforts to expand awareness of LSGMI in the community. The current idea is to have an event in the Haitian Community since many of the LSGMI clients belong to this community. Also in the works are forming affiliations with other organizations that can help complement the work LSGMI does.

Effie Silva reported on the Development Committee. Current efforts include gaining support for our existing events that will help raise funds and awareness. New efforts being developed include marketing and branding our work to other groups that might be interested providing support. One effort "Hola" will focus on the work we do for Hispanics. Josh Spector will be working to gain support for the Veteran Advocacy group. Marcia Rabinowitz reported that the 2015 Heart of Giving event will be held on May 13 honoring United States district judges Beth Bloom and Darrin Gayles. The goal is to secure \$20,000 in sponsors before the Save the Date is sent in mid-January. She asked for support from Board members to help achieve this. Effie reminded everyone of the DBR Holiday Judicial Reception on 12/11/14 to partially benefit LSGMI.

Jeff Crockett reviewed the proposed the program priorities. Margaret Moores explained the proposed changes in more detail. Upon motion made by Barnaby Min, seconded by Stephanie Carman, the 2015 Program Priorities were unanimously approved.

AGENDA ITEM 3: Approval of 2015 Private Attorney Involvement Plan

Vivian Chavez reviewed the proposed 2015 Private Attorney Involvement Plan and the process used to seek input. The plan was updated to reflect new LSC requirements which took effect Nov. 2014. Upon motion made by Barnaby Min, seconded by Stephanie Carman, the 2015 Private Attorney Involvement Plan was unanimously approved.

AGENDA ITEM 4: Certification of Program Integrity

Marcia Cypen advised that LSGMI is in compliance with program integrity requirements of Section 1610.8. Upon motion made by Darrell Payne, seconded by Jeff Crockett, the 2015 Certification of Program Integrity was unanimously approved.

AGENDA ITEM 5: Good & Welfare

Nexcy De La Rosa advised that the Gwen Cherry Black Women Lawyers Association will hold “Day at the Races” on March 29, 2015. The proceeds will be used to support the Gwen Cherry law student fellow at LSGMI. Teresa Enriquez will be doing Criminal Law training for the LSGMI attorneys December 11. The LSGMI Holiday party will be on Dec. 12 at 2:30 pm. All board members are invited.
