Message from the President

Time goes by so quickly, it makes me ponder what accomplishments occurred this summer for me, YRNA, and nursing.

We said good-bye to Joy this summer as she has moved to BC to share all that she's learned in the Yukon (and elsewhere) with those at ARNBC who will be sure to benefit from this knowledge (<u>http://www.arnbc.ca/images/pdfs/news-arnbc/ARNBC-new-ED-Aug-05.pdf</u>), A hiring committee was struck and meetings have continued all summer that will lead to recommendations to the YRNA board and our hiring of the next Executive Director.

The Canadian Nurses Association AGM and Biennial Convention was held in Winnipeg this summer, and attended by several YRNA members. I am very proud to report back to the Yukon that Jackie MacLaren did a fantastic job as a member of a panel leading a forum called *Indigenous Knowledge: A Policy and Practice Imperative*, where she was touted as 'Yukon RN; expert in traumainformed care and aboriginal communities'. I was equally proud of Carol Chiasson whose poster presentation entitled *First Nations Cultural Workshops: One Size Does Not Fit All* was not only well received, but a fabulous source of information that is so relevant to the Yukon.

Karima Velji RN PhD CHE was also sworn in as the new president of CNA during the Biennium. Karima has an admiration for the Yukon –having attended our last two AGMs. She often brags to audiences across the country about the Yukon, our small piece of picturesque paradise in the north, and a land where nursing definitely makes a huge difference. In fact, Karima's presidency tagline and her area of focus for the next two years were inspired during the trip that her and I took around the Carcross/Tagish loop back in May of this year. While in Carcross, touring the Community Health Centre and witnessing the Community Nurses in action, we had a wonderful conversation with Brook Davis –long time Yukon nurse, with experience in several communities. As Karima was visibly impressed with what Brook does for the community members, I made a comment about what Yukon RNs can and actually do in various settings, saying 'what if all RNs worked to their full potential? How much more healthcare could we deliver?! Thus was born Karima's tagline: *Unleash the power of registered nurses*.

This is done in conjunction with the National Aboriginal Day of June 21st. Please help me remember this recognition next year because I can think of several local deserving nurses.

Message from the President, continued

Still speaking from a national perspective, during my last two years on the CNA board, much of our time has been occupied with governance and bylaw changes that were needed for CNA to comply with new federal legislation. As of July 30, 2014, CNA's new *Articles of Continuance* and bylaws, approved at the June AGM in Winnipeg, were enacted under the new *Canada Not-for-profit Corporations Act*. Although that probably means little to most people, it means that CNA can continue as an entity –which was actually at risk because of this change in legislation. It also led to a new 'family of nurses' member class with CNA which will welcome independent and retired nurses as members of CNA for the first time in its 108 year history. Student nurses now have their own membership class as well. From a local perspective, YRNA as a jurisdictional member of CNA now has about three times the 'voice' at the national stage through a new voting structure which was initiated by your representative at CNA –me.

If tomorrow were my first day of school and I needed to give a presentation on what happened this summer with nursing, I think I'd have to concentrate on how YRNA, as Canada's smallest jurisdiction of nurses, plays an integral role nationally. We not only do amazing work affecting the lives and healthcare of Yukoners or those visiting our territory (that I've run out of room to showcase in my 'what happened this summer presentation'), but we also are represented extremely well on the national stage –something that makes me very proud.

YRNA is going through a transition of leadership, however, using the same consistent relational leadership approach, we continue to forge relationships with nurses, government, and other partners in an effort to maintain current relationships and build new ones too.

In August 2014, the Yukon Registered Nurses Association was accepted as an Associate Member to the National Council of State Boards of Nursing (NCSBN). YRNA is now a part of an international network along with fifty nine American boards, eight Canadian jurisdictions, and six international nursing councils.

Who is the NCSBN?

NCSBN is an independent, non-profit organization composed of member boards which are charged with the responsibility of providing regulatory excellence for public health, safety, and welfare. The organization has collaborated with member boards in exploring issues related to health care, government policy, nursing practice, and regulatory processes and initiatives. So what does this mean for YRNA?

It means that we now belong to a forum where we can learn, share, and have a dialogue with regulatory bodies from around the globe. This gives YRNA staff and its Board access to many NCSBN programs and services. This includes resources on how to delegate effectively, disciplinary action, documentation, ethics, critical thinking, cultural competence, and professional boundaries. We are connected to a collaborative leadership network which can assist the Association and its members in ensuring patient safety and public protection.

As the work of the Yukon RN moves closer and closer to the national and global stage, the Association is strategically collaborating with partners in the interest of public protection, patient safety, and the education of nurses. This proactive approach will assist the YRNA in ensuring that nursing regulation in the Yukon is timely, thoughtful, and responsive to the ever changing needs of Yukoners and our health care system.

With our induction, I am very excited to move the Association and its membership into regulatory innovation and nursing excellence, and most importantly, communicating this information back to the membership through outreach and engagement.


Education Fund Management Committee

Nurse Practitioners given ability to order specific diagnostic tests and program referrals in Yukon's hospitals

August 8, 2014

Yukon's Minister of Health and Social Services recently approved amendments to Yukon Hospital Corporation Medical Staff Rules, giving the territory's nurse practitioners (NPs) specific diagnostics ordering privileges within their expanded scopes.

This is a positive step forward in establishing a more collaborative care environment in Yukon and utilizing the expertise of all providers in our health system to provide timely, accessible and quality care. Effective immediately, these changes mean that NPs can now practice within more of their extended scope in Yukon hospitals, but will be limited to ordering specific diagnostic tests and program referrals. This includes:

On-site lab testing at Whitehorse General Hospital

On-site microbiology testing at Whitehorse General Hospital Referred out testing at Whitehorse General Hospital Public health serology screening Tumour marker requisition (with confirmed diagnosis of cancer) PHSA stool cultures Non-contrast plain radiography Ultrasound Screening and diagnostic mammography Refer to diabetes education program, therapy program, and dietician

At this time, NPs do not have "privileges" that would allow them to admit/discharge, order MRI or CT scans or prescribe medications. These changes require more in-depth discussions and additional amendments, which will be reviewed in a next phase after further consultation.

There are two NPs in Yukon. One has been approved and can now order these specific tests and make program referrals. The other individual has applied and we are now assessing credentials and scope of practice. On an interim basis, NPs will work under the review of our hospitals' Chief of Staff. NPs are also encouraged to use a health clinic's established processes for ordering and referrals in hospitals.


Notes on NCLEX (from the 7th Issue of the NCLEX Communiqué):

The NCLEX is developed by NCSBN to ensure public safety and protection through a fair, comprehensive and entry-level assessment that accurately reflects current nursing practice. NCSBN gathers information from nurses that represent regulatory bodies that utilize the NCLEX through detailed exam development activities. These data are used to develop and review item content that is found on the NCLEX.

During the preparation of the NCLEX for use in Canada, a concerted effort has been made to guarantee that item content is fair and accurately represents entry-level nursing practice in Canada. In order to assure this information is relevant to entry-level nursing in Canada, nurses from Canadian provinces were included in Item Review and Item Writing panels. The input of these volunteers has been instrumental in the preparation of the NCLEX for Canadian delivery.
