- incorporator can sign all the forms. If signatory is not one of the incorporators/cooperators/partners, a Board 3. Resolution/Partnership Agreement for the authorized signatory is required.

e.7. In case of alien retailer, current year's permit to engage in retail business under RA 1180.

e.8. Certificate of authority to engage in business in the Philippines from SEC, if the foreign capital investment exceeds 30% of the total capital stock.
