A Nominated Trainers Application form must be fully completed by each trainer, signed by the applicant and the Head of Centre/Organisation or senior member of staff, returned with attached photocopies of relevant certificates/qualifications and a passport sized photograph of the applicant. A CV alone is not acceptable and an incomplete form will lead to a delay in processing the application.

All trainers delivering SIA licence-linked qualifications are required to hold all of the following:

- Preparing to Teach in the Lifelong Learning Sector (PTLLS) or a recognised equivalent and/or higher level teaching qualification.
- The qualification(s) they are delivering (except to deliver Upskilling or Security Guarding, when they may hold Door Supervision instead).
- Three years' front line experience in the past ten years, relevant to the qualification(s) they are delivering.

To deliver Door Supervision or Upskilling, all trainers are also required to hold:

• A Level 3 qualification in the Delivery of Physical Intervention Skills or SIA approved equivalent, with an up-to-date certificate evidencing achievement of the annual refresher.

To deliver Door Supervision or Security Guarding, all trainers are also required to hold:

• A Level 3 or above qualification in the delivery of conflict management training endorsed by the SIA.
