# **Services after Installation**

The winning bidder will also provide the following locate and repair services for the college for 12 months beginning July 1, 2012 and ending June 30, 2013 and may be renewed at the College's discretion four (4) times coinciding with Fiscal Year, July 1 – June 30, no more than a 60 month contract.

### **Locate Services**

Locate services include, but are not limited to, responding to requests to dig by users of Georgia 811 and locating the path of the cable. All materials required to mark the cable path will be purchased and furnished by the winning bidder and will not be billed to Savannah Technical College.

The winning bidder must complete all the locate requests that originate from Georgia 811 during the 12 month contract.

### **Repair Services**

In the event that the fiber is cut or otherwise damaged in the utility easement, regardless of who is at fault, the winning bidder will immediately contact and get prior approval from the College to begin repairing Savannah Technical College's fiber.

Work will continue unstopped during daylight hours (except during inclement weather and other unsafe conditions) until the damage has been repaired. Repair splices may be done underground. Provide a handhole around splice locations.

The winning bidder must invoice Savannah Technical College for repair services. The invoice for repair incidents must be itemized with material and labor costs detailed and approved by the College.

Note: In the event of a conflict between previously released information and the information contained herein, the latter shall control.
