## **Attorney's Report:**

Attorney Verst presented **Ordinance No. 14-1201: Amending Chapter 131 of the Wilder Municipal Code regarding hunting and firearms in the City of Wilder. [Second Reading]**

David Luthie, resident of St. Johns Lane, asked council to consider putting a minimum land requirement that will permit anyone who meets this requirement able to hunt on their property.

Discussion ensued regarding other city regulations on hunting and the residents who attended previous meetings expressing their concerns about their safety.
