Do you know a friend, colleague, fellow TEMPO member or a corporation deserving of recognition for their mentoring, leadership and accomplishments? If so, we'd like to know.

TEMPO Milwaukee is seeking nominations for its 25th annual **Mentor Awards**. The awards luncheon, to be held on February 19, 2015, honors metro-Milwaukee area individuals and corporations making a difference through mentoring and leadership in their professions, communities and the lives of others.

Eligible candidates include local business and community leaders and professionals, TEMPO members and corporations. Award recipients will have a scholarship designated in their name, to a woman at a 4-year educational institution in the State of Wisconsin.

The following criteria will be used in determining the 2015 recipients:

Mentoring – Nominees have demonstrated extraordinary service and commitment in either formal or informal mentoring relationships.

Business Leadership – Nominees have shown substantial achievement in impacting the success of their business and/or women in business.

Community Leadership – Nominees have vision backed by action that has served to improve the corporate climate and/or social welfare of our community. In addition, the corporate nominees' mission must align with TEMPO's to further the impact of women in leadership.

Nominations are limited to the attached form detailing the nominee's qualifications, accomplishments and impact; and may be submitted electronically as a Word document, mailed or delivered to the TEMPO office at tempo@tempomilwaukee.org. Supporting letters/documents are helpful in the judging process, giving the judges insight into specific nominee qualifications matching the judging criteria. However, no more than three (3) supporting attachments can be accepted per nomination. No tapes, DVD's or binders will be accepted.
