ASSESSMENT & TREATMENT OF MALTREATED CHILDREN: INTRODUCTION TO THE NEUROSEQUENTIAL MODEL OF THERAPEUTICS - LIMITED SPACE

The development of a young child is profoundly influenced by experience. Experiences shape the organization of the brain, which, in turn, influences the e3motional, social, cognitive and physiological activities. Insights into this process come from understanding brain development. This session will provide an overview of key principles of neurodevelopment crucial for understanding the role of experience in defining functional and physical organization of the brain. Additionally, the session will provide an overview of the key functions of the brain, outline the hierarchy of brain development and provide neurodevelopment links to key functions of the brain and key times of development.

DOMESTIC VIOLENCE TRAINING - FOSTER PARENTS - LIMITED SPACE

The effects of family violence on children have often been unrecognized or under-estimated. This training program on the effects of family violence on children is for foster parents who are caring for children who may have witnessed family violence. The curriculum will cover the dynamics of intimate partner violence, the effects on children at various stages of development, the impact of family violence on attachment and the effects of trauma on children. Particular attention will be focused on the unique trauma and attachment experiences of First Nations children due to the enduring impact of the residential school system. Basic interventions for foster parents will be briefly reviewed. Finally, the role of the child welfare system in responding to family violence (and the inherent challenges) will be discussed.

MISSING & EXPLOITED CHILDREN'S CONFERENCE - LIMITED SPACE

MECC 2015 will centre around the high profile, complex investigation and prosecution of a man for offences that included possession of a massive collection of child pornography, and years of violent sexual offences against his daughters. The conference will explore the increasing interconnectedness of online and contact offenses. International experts in the field of sex offender behaviour, Dr. Peter Collins and Dr. Anna Salter, will be here to offer insights into this case and into the task of protecting children in an increasingly complex world.

TRAUMA & ATTACHMENT - FOSTER PARENTS AND SOCIAL WORKERS

This two day intensive workshop will focus on what happens to children as they experience trauma by how it effects their attachment patterns, and how those children grow up to become parents with attachment difficulties. Attachment forms a point of intervention for a caseworker in meeting a client, meeting their needs and formulating a relevant case plan. Attachment forms a point of intervention for a foster parent in connecting with a child, meeting their needs and providing care. Attachment patterns, which are essentially the brain developing in a certain trajectory, are our protective patterns. In order to understand how to work with someone, we must first know how we are being received in order to determine the best interventions someone would respond to. We will focus on the role of the caseworker in factoring in the data derived around a client's attachment stories, and for the foster parents, we will focus on the data around the child's attachment history coupled with that of the foster parent. There will be some small group discussion and breakout activities, and primarily lecture format.
