### INSTRUCTIONS

You have declared that you have been the subject of a disciplinary sanction.

You must fill out this form, which will be forwarded to a committee so that the OIQ can evaluate your file. Please declare all disciplinary decisions rendered in Québec imposing the revocation of your permit or the striking of your name from the roll, even temporarily, and all decisions rendered outside Québec that would have resulted in your permit being revoked or your name being struck from the roll if they had been rendered in Québec.

If you make this declaration the first time you register on the roll, the Board of Directors may reject your registration, especially if there is a connection between the offence committed and the exercise of the profession. However, if you are already registered on the roll, your declaration will not automatically result in the suspension or limitation of your current permit. Even though your registration will not actually be suspended, the committee will still evaluate whether you are entitled to practice in light of the information submitted. In any case (whether it is the first time you are registering on the roll or you are already registered on it), you will have an opportunity, if you so desire, to share your observations.
