A BILL FOR AN ACT

To further amend title 50 of the Code of the Federated States of Micronesia, as amended, by amending section 113 of chapter 1 and by enacting a new section 117 of chapter 1, requiring entry visas for certain nationals entering the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 113 of title 50 of the Code of the

2 Federated States of Micronesia, as amended by Public Laws No.

3 10-35 and 12-65, is hereby further amended to read as follows:

4 "Section 113. <u>Entry Permit Revolving Fund</u>.

- (1) The purpose of the Entry Permit Revolving Fund is to establish an ongoing revolving fund to allow revenue from the issuance and renewal of entry permits, entry visas and other relevant fees to be used for entry permit issuance and renewal[7] and entry visa issuance and renewal, when so designated by the Congress of the Federated States of Micronesia, and for training FSM
- 12 citizens to assume positions in the FSM workforce
- currently held by noncitizen workers.
- 14 Section 2. Title 50 of the Code of the Federated States of
- 15 Micronesia, as amended by Public Laws Nos. 10-14, 10-35, 10-140,
- 16 11-21 and 12-65, is hereby further amended by enacting a new
- 17 section 117 to read as follows:
- 18 "Section 117. Entry visas
- 19 <u>(1) Requirement</u>

1 An entry visa is required for all foreign citizens and nationals entering the Federated States of Micronesia; 3 provided HOWEVER, that the FSM will provide reciprocity 4 and not require an entry visa for citizens of countries 5 not imposing visa requirements on FSM citizens. (2) Issuance 6 7 An entry visa may be issued by all Federated States of Micronesia Embassies, Consulates and ports of entry. 8 9 (3) Types and Duration (a) Single entry visas shall allow one entry into 10 the Federated States of Micronesia and shall be valid 11 12 for a period of 30 days with provision for renewal 13 (b) Multiple entry visas shall allow multiple 14 entries into the Federates States of Micronesia and shall be valid for up to a year with provision for 15 16 renewal (c) Work visas shall allow multiple entries into 17 18 the Federated States of Micronesia for a definite term 19 of employment, up to three years, with provision for 20 renewal 21 (d) Student visas shall be valid for the duration 22 of enrollment at a school in the Federated States of 23 Micronesia, up to a period of three years, with 24 provision for renewal 25 (4) Fees
