**Season Dates:** Tribal Member: 11/07/15-12/13/15

**Fees:** Any Deer \$25.00  
Antlerless \$20.00  
Elder \$10.00

**Surcharge:** A \$5.00 surcharge is assessed to the first "2015" license purchase. Any additional "2015" license purchases will not be subject to the surcharge.

**Designated Hunters:** No Big Game Licensee may hunt for another except designated licensed *Tribal Members* who have obtained authorization by the SWO Fish and Wildlife Department. Designated hunting will only be allowed for SWO Tribal members. Upon authorization the designees name will be printed on the designators permit which must be in possession of the authorized hunter while hunting. The designated tags will be for antlerless only.

**Deadline:** These permits are available on a first come first serve basis.

**Limit:** One (1) White Tail Deer per tag  
One Rifle tag per Tribal Member, with the exception of authorized designees

**Antler Restriction:** Must be at least a 3x3 if antlered

**Hours:** One half-hour before sunrise to one half-hour after sunset.

**Permits:** Any Deer 275 (Two hundred seventy five)  
Antlerless 30 (Thirty)  
Elder 60 (Sixty)

**Hunter Report Cards:** All hunters are required to submit a hunter report card within 15 days of the close of the season. Year 2014 hunters who did not submit a hunter report card will be penalized a \$10.00 penalty fee which will be assessed to their 2015 license purchase.

**Color-coded Tribal Hunter Atlases:** New 2015 Tribal Atlases are available for \$25.00 ea.

**Payment:** Credit Card, Debit Card or Checks are accepted. Personal checks will be processed by E-Check. Cash is accepted if applying in person. Do not send cash in the mail. Please make checks payable to SWO Fish & Wildlife Dept.

**Refunds:** Any unsuccessful applicant will be refunded their payment. No license may be refunded or transferred after being issued. No refunds on Hunter Atlases.
