

#### A LETTER FROM THE FINANCE COMMITTEE

We are pleased to present this Annual Report to you for the fiscal year ending August 31, 2011. It represents our commitment to fiscal transparency and the responsible stewardship of the resources provided so graciously by you, our brothers and sisters in Christ. We want to thank all of you who have given so much of your time, talent, and treasure to our parish even in these difficult economic times. The Statements of Support for the Parish and Outreach Mission summarize the major sources of revenues and expenditures for the last two years and our budget for this year. We have included pie charts showing the sources of cash received and disbursed for the past year.

We recently completed a revision to the 10-year parish finance plan. The primary goal of our plan is to eliminate operating deficits while ensuring the long term continuation of all of our existing programs. We foresee declining operating deficits over the next eight years. In October, as part of our plan, we elected to make an early payback of \$600,000 of our \$6 million restoration loan due in large part to the success of our Capital Campaign. This will decrease the loan period from 15 to 13 years and save \$539,000 in interest costs. Last year we also finalized a long term interior maintenance plan for the church that will help maintain our newly restored interior for years to come. The budget for this maintenance plan is included in the finance plan.

Last year we had an operating deficit of \$205,519. Although we planned to operate at a deficit, it was larger than budgeted due to higher expenses in Maintenance & Operations, Administrative Support, and Outreach Mission coupled with a decline in our major source of income, our Sunday Collections. Last year our Sunday Collections of \$517,227 declined \$17,171 or 3.2%, their lowest level in four years. Over the last four years the Sunday Collections have increased by only .3% annually while our total expenses increased 4.4% annually during the same period.

We can no longer rely on the 17<sup>th</sup> Street rental stream as a cushion for our operating deficit as this income is now primarily dedicated to pay the loan payments on our \$6 million restoration loan. Although we expect to see small increases in other income next year, from votive shrines & candles and weddings now that the church renovation is completed, we still need your increased support. We especially need your contribution to the Sunday Collection, to fund the continuing ministries of the parish and eliminate the operating deficits. We ask that you prayerfully consider increasing your donation, if you can. By way of example, if each parishioner attending on an average Sunday increased by \$3 the amount they give each week, we could eliminate this year's projected \$120,000 deficit. We recognize that the current economic climate is very poor, and that many of us are struggling and may not be able to increase our giving at all, but perhaps there are others who are doing better and can contribute more than an additional \$3 each week.

We acknowledge the trust placed in us by the pastor and the parish and commit ourselves to remain true to that trust and to always maintain credibility with the parish, the larger Church, and society. We thank you once again for your support and for the sacrifices you make on behalf of this wonderful parish of ours even in these most difficult economic times.

#### A LETTER FROM THE PASTOR

As I looked at all the many photos from September 1, 2010, to August 31, 2011, covering this Annual Report, it was truly hard to select just what to include. The photos underscored another rich, vibrant, spirit-filled year at St. Francis Xavier, my 5<sup>th</sup> as pastor.

In addition to our annual events, such as the Ministry Fair, Blessing of the Animals, Lessons and Carols, Children's Christmas Pageant, the Mission Mass, L-STEP graduations, the RCIA Program, our Triduum Celebrations, First Communion, and Confirmation, there were quite a few special happenings.

Our parishioner Matthew Phelps dedicated our organ on Columbus Day with a special concert. Also in October, Jesuit author Monty Williams offered a program on *Attention and the Spiritual Life*. In February we sponsored the 7<sup>th</sup> Annual Inter-Religious Prayer Service, featuring Jesuit theologian and author Roger Haight. In March Jesuit author James Martin joined us for a discussion of his various works.

The weekend of November 21<sup>st</sup> is memorable because we introduced our first colorful bulletin. It featured photos of Sergio Militello's organ concert. Also in concert throughout the year, we had our erstwhile music ministers, Larry Rosania, Joe Simmons, and Michael Ward, as well the Peragallo family who provided us with a concert and lesson about our new organ. Our parishioners and cantors Anna & Alan Ostroff performed the *My Way* concert with music of Frank Sinatra, followed a few weeks later by Xavier Company's performance of *Whom Shall I Send?* 

On World AIDS Day, December 1st, parishioner and Maryknoll priest Don Doherty presided at a Memorial Mass and on May 6th Bishop Joseph Sullivan of Brooklyn joined us for the 18th Anniversary LGBT Ministries Mass.

We were particularly honored in the Spring to receive recognition for our Church's renovation and restoration with prestigious awards from both the Landmarks Preservation Commission and the Victorian Society. Thomas Fenniman our parish architect was also selected by his peers to receive the prestigious American Institute of Architects (AIA) Faith & Form Award for his work on our Church. In June, we launched our campaign to raise money for our 15<sup>th</sup> Street Curb-Cut, which became a reality in what is now this current fiscal year.

These are just a few highlights from the many wonderful events and celebrations that take place during a single year at SFX. Naturally, to continue to fund these many programs and activities we need your support. Our parish Finance Committee, who so faithfully and expertly helps me to oversee our budget, income and expenses, all agree that we cannot cut expenses without cutting services, ministries and events. We would then, however, no longer be the same parish, a parish with a challenging Mission Statement and history of real inclusivity, supporting the poor and marginalized.

What is necessary to sustain our parish is that all parishioners pitch in and commit to just a bit more by way of weekly offerings. There is really no special magic in multiples of \$5. To offer \$6 or \$7 instead of \$5 or to offer \$13 instead of \$10 or \$27 or \$28 instead of \$25 would truly help us eliminate our operating deficit. Please consider a dollar or two or three extra in your weekly giving. We will all benefit so very much.

May our loving God continue to bless you and our parish.





# **OUTREACH MISSION: HIGHLIGHTS OF THE YEAR IN REVIEW**

#### WELCOME TABLE SOUP KITCHEN

56,947 meals were served this past year, including 13,193 to seniors and 50 to children. The average weekly attendance increased from 960 to 1,095. This represents a 14% increase in the overall number of meals served (on top of a 9.7% increase last year) and a nearly 16% increase in the number of meals served to seniors. It also highlights the sad reality that families with children, a population not seen downstairs in a decade, must now seek out soup kitchens to feed themselves.

#### FOOD PANTRIES

Served families representing 4,390 people, including 1,171 children and 721 seniors (a 21% increase in the number of seniors), and distributed 178 Thanksgiving baskets (including turkeys) to guests.

# HURTADO SHELTER

More than 5,000 men and 30 women were welcomed as guests in our facility that is open 7 nights a week and accommodates 15 guests per night in the winter and 18 in the summer. On August 31, 2011, the shelter had been open for 516 consecutive nights.

# LIFE-SKILLS TRAINING & EMPOWERMENT PROGRAM

22 participants graduated from L-STEP over the course of two semesters, a 120% increase from the previous year.

#### ALL SAINTS CLOTHING ROOM

The Clothing Room distributed toiletries and clothing to 1,353 individuals.

# **ACCOMPLISHMENTS**

# 2011 was a banner year for Xavier Mission!

As part of our Go Green! Campaign, the Mission applied for a \$70,129 grant from the USDA to replace our four aging, inefficient refrigerator and freezer units with one energy-efficient combination walk-in fridge/freezer. We were one of only 39 programs across the entire United States chosen to receive funding. Our new unit was successfully installed in mid-August and is functioning like a dream. We also received a \$10,000 grant from the Hyde & Watson Foundation to purchase new energy-efficient convection ovens. In collaboration with Xavier High School, we installed energy-efficient hand dryers in the Hurtado Hall bathrooms, replacing paper towels. In conjunction with ConEd, we took part in a program to replace old lighting fixtures in our offices with energy-efficient lighting fixtures, including light sensors in the new church bathrooms.

Xavier Mission redefined its goals and mission, and our commitment to them, with the unveiling of a new Mission Statement that better reflects the work we do in our community. We also created a beautiful new logo that expresses our identity as a faith-based social outreach program. We thank the Mission Steering Committee and Nancy Fava for their work on these projects.

This past year also saw the successful completion of our L-STEP Working Group, a collaborative of volunteers working together to define the mission, goals and process of our Life-Skills Training & Empowerment Program. The final product was a comprehensive manual describing the entire program, including a mission statement, goals & objectives, and measurable outcomes, as well as the creation of volunteer and participant recruitment brochures. We also launched the extremely successful "Sponsor a Participant Program" in the spring, which raised enough money to cover the costs of all of our L-STEP participants for the semester. Additionally, the Beck Institute for Religion and Poverty at Fordham University designed a research project to measure the effectiveness of L-STEP and other programs like it. The first phase of the project will be completed in December 2011.

With the help of our AmeriCorps VISTA volunteer, Ida Beal, Xavier took the lead in resurrecting the Chelsea-Westside Neighborhood Network, a collaborative of neighborhood outreach programs coming together to share information, best practices and support. The re-established Network has already successfully collaborated on several grants for new projects.

For our efforts to provide food and assistance to disenfranchised New Yorkers, to adopt environmental sustainability into our programs, and to go beyond food to include legal, health, and benefits services to our guests, Xavier Mission received the 2011 Agency Excellence Award from the Food Bank for New York City. The Agency Excellence Award is presented to only one of the Food Bank's 1,100 member agencies each year. We are extremely honored and proud to be the recipient of this award and we thank the Food Bank for its acknowledgment of the efforts of our amazing volunteers.

Xavier Mission continued its successful partnerships with numerous organizations to provide quality services to the guests of our programs. Highlights of these partnerships include the Thanksgiving Food Drive and meal service in conjunction with Xavier and Loyola High Schools and the St. Francis Food Pantries and Shelters, and the Day of Dignity event with Islamic Relief USA. Our ongoing partnerships with NYU Law School REACH and Chiropractic for Humanity help to ensure that our guests receive much more than food—they receive assistance with legal and housing issues, entitlement benefits and tax refunds, and the healing touch of chiropractic care.

We offer our deepest gratitude to our thousands of volunteers and hundreds of donors who make this work possible. You are the realization of God's love on earth and are truly an inspiration for us all. Thank You!!









#### CHALLENGES IN THE YEAR AHEAD

We are particularly concerned about the impending budget decisions that will be decided by the SuperCommittee of Congressional delegates. All food and nutrition programs, including funding for our own programs as well as funding for crucial assistance programs such as SNAP/Food Stamps, are in danger of being targeted for cuts. While our numbers have skyrocketed over the past few years, our federal funding has already begun to suffer cuts. Further decreases to our programs or to our guests' benefits will be disastrous and will further widen the ever-increasing gulf between very rich and very poor in this country.


In addition to financial issues, we are still concerned about our shelter and others like it. The Department of Homeless Services' restructuring of the Emergency Shelter Network has been detrimental to the homeless population of New York City—specifically the men served by our shelter and others in the faith-based network. We continue to be active in the ongoing dialogue with DHS, exploring new methods for dealing with the issue of homelessness in our city, a problem which has hit an all-time high over the last year.

As always, we ask for your continued gifts of time, talent and treasure to ensure the continuance of our programs. This year especially, we also ask for the gift of your voice raised in solidarity and support with the poor, homeless and hungry in our city.




