#### GENERAL RELEASE, INDEMNITY AND HOLD HARMLESS AGREEMENT

#### **Frequently Asked Questions**

#### What is Real Life Sports Park?

Real Life Sports Park is a 37-acre tract of land on the campus of River City Community Church that has been dedicated to the use of serving children and families in the community through sports and recreational activities.

#### What is my money used for?

We have four sports fields that are currently being used by GRAYSA, Northeast Vikings, and Alamo City Bull, with over 1500 children participating. These fields need sports lighting, irrigation, and permanent restrooms, for a start. Long-term plans include a track, concession stands, and a full gym.

#### What difference can our money make?

Studies show that the most formidable years of a person's life are their school years, when the very foundation of a life is being established. Who a person will become is often determined by what they are taught during those years. We believe that the positive support from encouraging coaching, the discipline of team sports, and the friendships that are built within a team, will make a lasting impact on children's lives.
