

## **Public Adjuster Business Entity Application-PA-2**

For Corporation, Association or Partnership

## Instructions:

Fee Requirement: Attach a check or money order for \$250 payable to the Director of Insurance.

Bond or Letter of Credit Requirement: All applications for public adjusters licenses must be accompanied by a surety bond or irrevocable letter of credit in the amount of \$20,000.

The proper bond (Form PAB) must contain:

- The name of the principal/licensee as it appears on the application;
- The principal's address as it appears on the application for license;
- The surety company's name and company number;
- The bond number;
- Original signature of the principal and the surety company's officer or attorney-in-fact.

Contract Requirement: A Public Insurance Adjuster shall not provide services until a written contract with the insured
