The Consent to Use Form on the reverse is not required for tax preparation, but will allow us to reference your tax return for financial planning purposes, if applicable.

ALL clients **M UST** fill out the portion of the organizer that contains your name, occupation, phone numbers, address, and e-mail address, at a minimum. Completion of the entire organizer and checklist is appreciated and highly recommended. It is important that this organizer is signed and is in the files for future reference.

ALL clients **M UST** answer the questions and sign the enclosed questionnaire.

There will be an <u>ADDITION CHARGE OF \$25</u> for all tax appointments scheduled on or after **April 1**. Please call early to make your appointment.

"CORRESPONDENCE" CLIENTS: There will be an <u>ADDITIONAL CHARGE OF \$25</u> if your initial transmission of information to us is dated or postmarked after March 15 and \$50 if the initial submission is after **April 1**. If some of your information will be available by these deadlines, please send us any information that you may have so that we can begin working on your tax return. We will **NOT** charge extra for additional information that we request after March 15.

<u>Client Portal Delivery of Tax Returns!</u>! Our default method of delivering tax returns has changed and will now be sent via Client Portal, aka "Cloud Cabinet". If you do not already have a login and password, information will be e-mailed to you after your tax preparation interview. Once logged in you will have access to your Tax Return and Source Documents for 2014 and the three previous years, if your return was prepared by this firm. A copy of your Tax Return will be mailed to you at NO EXTRA CHARGE <u>upon request</u>. Any Tax Returns required to be filed by mail will also be mailed at no extra charge.

NEW EXTENSION FILING PROCESS. Need to file an extension? We will require all clients to sign an Extension Agreement and pay a \$25 deposit. THIS IS NOT AN ADDITIONAL FEE. All \$25 deposits will be applied to the tax preparation bill once the tax return has been completed.

SEAL BEACH LOCATION REMINDER: Our office is located in Seal Beach, CA off of Seal Beach Blvd, where the 405 meets the 605 freeway, close to Los Alamitos and Rossmoor, in the Bixby Office Park. There is elevator access to the 3rd floor.

<u>Some Tax Organizer Tips.</u> Please keep the following in mind as you fill out your 2014 Tax Organizer:

Preparation: Please come prepared and add up all tax receipts **IN ADVANCE**.

Check W-2's and 1099's: Please check for accuracy **BEFORE** your appointment.

If you sold stock: Make sure to bring your 1099'-B Forms AND the cost basis information.

If you sold a home. Please bring closing statements for the purchase and sale

tax return. For California vehicles, the deductible portion is listed on the bill as "License Fee" with the verbiage, "This may be a tax deduction" next to it. Please have this information available at your tax appointment. You can also check out the DMV website at www.dmv.ca.gov for more information.

<u>Medicare Premiums</u>. In the medical section of the 2014 Tax Organizer, please indicate whether or not you have included your Medicare premiums as part of your insurance premiums. We want to make sure we are not duplicating this information as it is reported on your Social Security Statement (Form 1099-SSA).

<u>State Estimated Payment</u>. If you had a large increase in income during 2014, it might be wise to make your state tax payment before December 31, 2014. The amount may be deductible on your federal return as an itemized deduction. (Sorry, the federal tax payments are not deductible on the state return). To verify that a pre-payment of State income tax would be of benefit to you, please call the office.

<u>SPECIAL NOTE FOR MINISTERS</u>: **Establishing your 2015 Housing allowance**. Remember, your housing allowance should be established each year and in advance. This firm recommends that you establish your 2015 housing allowance in December. If you have any questions, or would like some guidance in this area, please give us a call.
