Mandatory Immunizations

The following immunizations are mandatory and must be kept up to date. In the event immunizations are not up to date and there is an outbreak of disease in the day care, you will not be allowed to work until the outbreak is declared over.

It should be noted that in the event of an outbreak of disease, any staff member whose immunizations are not up to date will not be allowed to work until the outbreak is declared over. This applies even if a medical exemption or a conscience or religious belief affidavit is in place.
