Terms & Conditions

The following terms and conditions apply to the Atlanta Police Foundation's Relocation Bonus Incentive Program. All terms and conditions must be met in order to be eligible for the relocation bonus funds.

- 1. Applicant must be an **active, sworn officer of the Atlanta Police Department**.
- 2. Applicant **must have relocated to the City of Atlanta on or after November 1, 2010**. Relocations include both out-of-state and local relocations.
- 3. Relocation bonus incentive is **applicable to both purchases AND rentals**. Dwelling must be located within the six patrol zones of the City of Atlanta.
- 4. Dwelling **must be the applicant's primary residence**. Relocation bonus incentive does not apply to dwellings applicant intends to use as a 2nd home or as investment property.
- 5. Applicant must provide documentation to **demonstrate intent to reside in the City of Atlanta for a period of at least 12 months** from the date of lease or purchase. Relocation bonus does not apply to relocations for periods of less than 12 months.
- 6. Existing lease agreements must have at least 6 months remaining. Applicants with less than 6 months remaining on current lease may be subject to demonstrating lease renewal or extension before relocation bonus will be paid.
- 7. Relocation bonus is payable in one installment of \$1,000 for purchases and in two installments of \$500 each for rentals. The 1st installment will be paid upon approval of application. The 2nd installment will be paid 6 months following initial installment upon verification that applicant still resides in the City of Atlanta. Applicant is responsible for applying for the 2nd installment.
- 8. **Relocation bonus is a one-time bonus**. Bonus IS NOT applicable to multiple relocations.
- 9. All **applications are subject to periodic quality control review** by the Atlanta Police Foundation.
- 10. Any agreement between housing provider and officer for services rendered must conform to the current policies and procedures of the Atlanta Police Department.

Housing Incentive Program – Relocation Bonus Application Downtown Addendum

The Atlanta Downtown Improvement District (ADID) has committed to match the Atlanta Police Foundation (APF) Relocation Bonus Incentive for officers moving to Downtown. In addition to receiving \$1,000 for relocating to the City of Atlanta, applicants are eligible to receive an additional \$1,000 for relocating to Downtown – for a total relocation bonus of \$2,000.

Who's Eligible?

The Downtown incentive is open to any active, sworn Atlanta police officer who relocates to Downtown on or after March 1, 2011.

Eligible Properties:

The Downtown incentive is applicable to both purchases AND rentals within the boundaries of North Avenue, Boulevard, I-20, and Northside Drive. Must be primary residence.

Terms & Conditions:

- 1. Applicant must be an active, sworn officer of the Atlanta Police Department (APD).
- 2. Applicant must have relocated to Downtown on or after March 1, 2011.
- 3. The Downtown incentive is **applicable to both purchases AND rentals** within the boundaries of North Avenue, Boulevard, I-20, and Northside Drive.
- 4. Dwelling **must be the officer's primary residence**. Relocation bonus does not apply to dwellings that applicant intends to use as a 2nd home or as investment property.
- 5. The Downtown incentive is payable in two installments of \$1000 each. The 1st installment is payable upon approval of initial application. The 2nd installment is payable 6 months following the 1st installment upon verification that officer still resides in Downtown. Officer is responsible for applying for the 2nd installment.
- 6. The Downtown incentive is a one-time bonus. Bonus DOES NOT apply to multiple relocations.
- 7. All **applications are subject to periodic quality control** review by the Atlanta Police Foundation.
- 8. Any agreements for services rendered by officer must conform to the current policies and procedures of the Atlanta Police Department.

Housing Incentive Program – Relocation Bonus Application Buckhead Addendum

The Buckhead Community Improvement District (CID) and the Buckhead Coalition have committed to double the Atlanta Police Foundation (APF) Relocation Bonus Incentive for Atlanta police officers moving to Buckhead. In addition to receiving \$1,000 for relocating to the City of Atlanta, applicants are eligible to receive an additional \$2,000 for relocating to Buckhead – for a total relocation bonus of \$3,000.

Who's Eligible?

The Buckhead incentive is open to any active, sworn Atlanta police officer who relocates to Buckhead on or after September 1, 2011 (July 1, 2011 for properties located within the Buckhead CID boundaries).

Eligible Properties:

The Buckhead incentive is applicable to both purchases AND rentals within the boundaries of Buckhead and the Buckhead CID.

Buckhead Boundaries:

The Buckhead boundaries are defined as the city-limits/DeKalb County line on the east; the city-limits Sandy Springs line on the north; the city-limits/Cobb County line on the west, and Peachtree Creek from the Chattahoochee River to I-75, I-75 to I-85, and I-85 to DeKalb County on the south.*

Buckhead CID Boundaries

The Buckhead Community Improvement District (CID) is the area of major offices, hotel and retail developments within Buckhead and includes Peachtree Rd. from Sheridan Dr. northeast to Roxboro Rd.; Paces Ferry Rd. from E. Andrews Dr. east to Piedmont Rd., and Piedmont Rd. from Peachtree northwest to Habersham Rd.*

Terms & Conditions:

- 1. Applicant must be an active, sworn officer of the Atlanta Police Department (APD).
- 2. Applicant must have relocated to Buckhead on or after September 1, 2011 (July 1, 2011 for properties located within the CID boundaries).
- 3. The Buckhead incentive is **applicable to both purchases AND rentals** within the boundaries of Buckhead and the Buckhead CID as defined within this addendum.
- 4. Dwelling **must be the officer's primary residence**. Relocation bonus does not apply to dwellings that applicant intends to use as a 2nd home or as investment property.
- 5. The Buckhead incentive is **contingent upon officer residing in Buckhead for a period of 2 years** following receipt of relocation bonus funds.
- 6. The Buckhead incentive is contingent upon officer's commitment to provide 1 hour of civic service in Buckhead during the first 6 months, plus an additional 1 hour during the following 12 months, as coordinated by the Buckhead Coalition. (Note: The civic service requirement does not apply to officers residing within the boundaries of the Buckhead CID.)
- 7. **The Buckhead incentive is payable in two installments of \$1500 each**. The 1st installment is payable upon approval of initial application. The 2nd installment is payable 12 months following the 1st installment upon verification that officer still resides in Buckhead. Officer is responsible for applying for the 2nd installment.
- 8. The Buckhead incentive is a one-time bonus. Bonus DOES NOT apply to multiple relocations.
- 9. All **applications are subject to periodic quality control review** by the Atlanta Police Foundation.
- 10. Any agreements for services rendered by officer must conform to the current policies and procedures of the Atlanta Police Department.
