## WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

WAIVER: In consideration of my desire to take advantage of school provided transportation — I, for myself, my heirs, personal representatives or assigns, do hereby release,
waive, discharge, and covenant not to sue Western Christian School, its officers, employees, and agents from liability from any and all claims including the negligence
of Western Christian School, its officers, employees and agents, resulting in personal injury, bodily injury (including death), and property loss arising from, but not limited

**ASSUMPTION OF RISKS:** School provided transportation carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary, but range from 1) minor injuries such as scratches, bruises, and sprains 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions to 3) catastrophic injuries including paralysis and death.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent to school provided transportation. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

**INDEMNIFICATION AND HOLD HARMLESS:** I also agree to INDEMNITY AND HOLD Western Christian School HARMLESS from any and all claims, actions, suits, procedures, costs, expense, damages and liabilities, including attorney's fees brought as a result of my use of school provided transportation and to reimburse them for any such expenses incurred.

**SEVERABILITY:** The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

ACKNOWLEDGEMENT OF UNDERSTANDING: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law. SCHOOL BUS SAFETY RULES AND GUIDELINES: The State of California have established rules and regulations for students riding school buses. Student compliance is essential. Parents are asked to promote compliance by reading these rules and regulations and discussing them with their student(s).

California Code of Regulations Title 5, Section 14103(a) states that: "Pupils transported in a school bus or in a school pupil activity bus shall be under the authority of, and responsible directly to, the driver of the bus, and the driver shall be held responsible for the orderly conduct of the pupils while they are on the bus or being escorted across a street, highway, or road. Continued disorderly conduct or persistent refusal to submit to the authority of the driver shall be sufficient reason for a pupil to be denied transportation. A bus driver shall not require any pupil to leave the bus enroute between home and school or other destinations."

## AT THE STOP

- It is recommended that parents/guardians make arrangements to receive students when they are returned to their bus stops at the end of the day.
- Please do not seek pick-up or drop-off at any location other than an established stop, except as requested in advance through the Transportation Safety
  Administrator and approved by the Administrator.
- Students must arrive at the bus stop at least five minutes before departure. Last-minute arrivals create traffic hazards, pedestrian risks, and schedule delays.
- Under no circumstances should a late rider or his/her parents try to flag down a bus that is departing or attempt to block its departure.
- Students must stand back at least 12 feet from the curb.
- Continue to stand in an orderly manner until the bus has arrived and wait until the driver signals you in.
- Do not play or rough house, as this could drive a student into the traffic flow.
- · Respect fellow riders, their property, the property of bus stop neighbors, and the tranquility of the neighborhood.

## ON THE BUS

- Remain in your seat, facing forward, for the duration of the trip.
- · Keep emergency exits and aisles clear at all times.
- Respect the window boundary: No body parts protruding. No items tossed. Nothing shouted.
- Respect other riders' personal space: No physical or verbal attacks. No taunts. No harassment. No bullying.
- Do not disrupt the driver with your voice or actions.
- · No loud noise, shouting, profanity, or boisterous conduct.
- Do not tamper with bus controls, emergency exits or safety equipment.
- No eating or drinking while on the bus (includes sunflower seeds).
- Do not bring hazardous or destructive objects on the bus.
- Animals or pets may not be brought on the bus.
- This is your school bus, keep it clean.
- Only assigned passengers are allowed to ride the bus. A permission slip from the parent will be required to ride the bus for a one-time rider (morning or afternoon).
- First failure to abide by the foregoing rules will result in a verbal warning from the driver. A second violation will be reported to the administration.
