Regional Delegate:

Hello ORSCNA Family!

On the last weekend of October, I attended the second meeting of the U.S. Fellowship Assembly (USFA) in Tulsa, OK. Although I don't have actual attendance figures, based on my personal observations & what I've gathered, attendance at this event was about half of the attendance at the first USFA that was held in Wichita, KS in March. Present in Tulsa were several NA members who are (obviously) very passionate about this movement and a number of other NA members who were there for the same purpose as us... to gather information. Other US Regions that had sent either their Regional Delegate (RD) and/or their Regional Delegate Alternate (RDA) included: Free State (Central Maryland & Delaware), Mid-Atlantic (Northeastern Pennsylvania), Iowa, OK (Oklahoma), Utah and Wisconsin.

The weekend started off Friday evening with introductions followed by a speaker meeting, featuring an NA member who has been actively involved with service in the Asia-Pacific Zonal Forum (APF) since its inception. Saturday morning was an open forum discussion on the "Wichita Accord Proposals 1, 2 & 3". When we broke for lunch, an open, unplanned & informal meeting of RD's & RDA's (and others) was called for by the RD from Wisconsin at which time we discussed how this movement "fits in" with the current Service System Project, the possibility of "work-shopping" this along with the Conference Agenda Report (CAR) and Conference Approval Track (CAT) in our regions, and meeting with other US regions to have further discussion and/or take action in this regard during our time at the World Service Conference (WSC). After lunch, there was a service history workshop which presented an overview of the movement to form a United States Service Conference since it was first suggested in 1987, and this was followed by discussion of the off-site & on-site voting process that had been conducted and what future actions the voting results might suggest. Following dinner, another speaker meeting was held which featured an NA member who shared his experience of service involvement in the formative years of the Canadian Assembly (CANA).

Then the voting results were presented. Of the 161 groups that had registered with the USFA (which made them eligible to vote), 127 groups cast votes on Proposal #1 and only 88 groups cast votes on Proposals #2 & #3:

☐ Proposal #1 ("Does your group want to help create a United States Service Conference?") – 107 voted in favor and 20 voted against this proposal; 34 groups cast no vote at all;

☐ Proposal #2 ("USSC Service Manual Proposal") – 38 voted in favor and 50 voted against this proposal; 73 groups cast no vote at all; and

☐ Proposal #3 ("actual creation & composition of United States Service Conference") – 40 voted in favor and 48 voted against this proposal; 73 groups cast no vote at all.

(It was reported to me by the Wisconsin RD that 30% of the votes cast were brought to the USFA by the Iowa & Wisconsin RD's.) One Area (??) and one Region (OK) cast votes – both supported Proposal #1 and opposed Proposals #2 & #3. (It should also be noted that the 2010 Conference Report accounts for 13,815 groups in 56 US regions; however, another 14 US regions either submitted no report or did not provide information on the number of groups

in their regions. Therefore, it is estimated that there are 15,000-16,000 NA groups within the US.) Although it was discussed that the total number of voting groups was less than 1% of the total number of NA groups in the US, and that many groups not present/not voting are actually in silent opposition to this "movement", it was obvious that the general consensus of those present that the voting results indicated support for Proposal #1.

The weekend wrapped up Sunday morning with bidding & discussion on when & where to conduct the next meeting – United States Fellowship Assembly III. Three NA communities offered bids to host the event: Fort Worth, TX (Fort Worth Area / Lone Star Region); Fort Lauderdale, FL (Gold Coast Area / South Florida Region); and the Wisconsin Region. A vote by show of hands was taken on the location and the Wisconsin Region was chosen. When it came to discussing possible dates, there was much talk about dates in the Spring of 2012, but several RD's & RDA's pointed out that much of the Spring will be consumed conducting workshops on the CAR & CAT in their Regions. Eventually, it was agreed to allow the Wisconsin Region flexibility by directing that they schedule the event sometime in the month of June. This discussion was followed by a motion (made, seconded & passed) to create a United States Service Conference Ad-Hoc Committee responsible to the USFA-registered groups. Tasks to be performed by this USSC Ad-hoc Committee would be as follows:

- ☐ To draft a basic Statement of Purpose & Function for the USSC to be approved at USFA III;
- ☐ To draft a Vision Statement for the USSC to be approved at USFA III; and
- ☐ To participate in the current service structure as well as possible.

My expenses to attend this event were as follows:

\$ 370.30 round trip airfare (for 1) from Louisville, KY to Tulsa, OK
113.50 overnight accommodations (2 nights) at the Tulsa Select Hotel (Conf. #988787)
27.00 long-term parking at Louisville Airport (3 days)
\$ 510.80 total expenses incurred (10/28/11 – 10/30/11)

I've heard that many of you have already begun reviewing the 2012 Conference Agenda Report (CAR) in your own Areas; and I'm hopeful that each of our member Areas is planning to send their RCM, Alt. RCM, and any other interested NA members to the Multi-Regional CAR/CAT Workshop that we're hosting in Perrysburg, OH on Feb. 10th-12th. By attending this Multi-Regional Workshop, NA members will have more knowledge of the information, as well as the added commentary, questions & concerns of those attending from other areas & regions, to bring to the table when more localized workshops are held. Plus they'll be able to discuss not only the CAR but also the Conference Approval Track (CAT).

Following that weekend, I'm anticipating that most Areas will want to conduct some form of more localized CAR/CAT Workshop. It would be great if Areas could agree to conduct Multi-Area CAR/CAT Workshops - not only to conserve cost, but also to make the most efficient use of our time (Charles, myself, and all of us). I've given this quite a bit of thought. Looking at the calendar, we'll have 9 weeks (8 weekends) between the Multi-Regional CAR/CAT Workshop and the April RSC Meeting:

- ☐ February – 18th & 19th; 25th & 26th
- ☐ March – 3rd & 4th; 10th & 11th; 17th & 18th; 24th & 25th; 31st
- ☐ April – 1st; 7th & 8th (Easter Sunday)

Presently, my only days off work are Saturdays. I'm not sure what Charles' availability is like.

I would propose that we could cover the Region with (6) localized CAR/CAT Workshops as follows:

☐ Sat, Feb. 18th – a workshop in Mansfield, prior to the annual AQUA event to accommodate NA members from the Finally Free & Mid-Ohio Areas. If Charles could help to facilitate this workshop, then I would be available to facilitate a similar workshop in either Cincinnati (to accommodate NA members from the Greater Cincinnati & Hamilton/Middletown Areas) or Portsmouth (to accommodate NA members from Area 13 & the Kentucky/Ohio Recovery Area).

☐ Sat., Feb. 25th – (the same weekend as TACNA) I could be available to facilitate a workshop in Columbus to accommodate NA members from the Central Ohio & Mid-East Ohio Areas.

☐ Sat., Mar. 3rd – a workshop in Lima to accommodate NA members from the Best Little, Miami Valley & Northwest Ohio Areas. And again, if Charles could help to facilitate this workshop, then I would be available to facilitate a similar workshop in either Cincinnati or Portsmouth.

☐ Sat., Mar. 10th – a workshop in Dayton to accommodate NA members from the Dayton, Five Rivers, Miami Valley & Springfield Areas.

Just my thoughts.... Perhaps we can discuss this in the RD/RCM Meeting this afternoon.

A reminder... The 2012 World Service Conference (WSC) is rapidly approaching and I've begun work on our Region's bi-annual report to the Worldwide Fellowship of NA. I'm hopeful that Areas have included in your reports to the Region information on the number of NA groups, meetings & H&I panels, as well as anything else you feel might be important to let the NA Fellowship know about.

COASCNA (Central Ohio Area)

Dear Family,

First of all welcome to the Central Ohio Area. I would like to apologize for the lack of morning treats. I was told by one staff we could have them but the lady who handled the final paper work said no snacks. I have set out a print of all our Saturday evening meetings. Please feel free to find a meeting tonight and share your recovery with us. This is the hotel where OCNA will be held so now you know how to get here. Please join us in May. In November we had an area service learning day that was well put together and seemed well attended. It was an excellent presentation of the HOW of all our area subcommittees that make up ASC. In December we had our annual Add-a-Thon which helps us get through the Christmas time. It was nonstop meetings, fellowship, and food from 9am Christmas eve till the dance which was over around midnight Christmas night. On December 31, we had two excellent speakers and then a dance to bring in the new year. One of the really beautiful things about these two functions was the high level of unity. Building unity is one of the main goals our area is focusing on this year. We recently hosted our annual convention. It appeared to be a success and there were some great workshops and speakers. Our area groups are continuing to grow and be stable. Our outreach sub-committee has struggled for a while but seems to be making headway. We are currently looking for A Women in Unity chairperson so that function is in the works. On 2/25/2012 our area will be hosting a CAR workshop. It will be held from 1pm to 5pm at the Just for Today Club which is located at 1008 E Livingston Ave here in Columbus. Flyers are on the table: please take some. I talked with our RD, Dave L., about this and what he suggested is that the outlying areas near the Central Ohio Area join us for this workshop so that all areas can be as well advised as possible about the Conference Agenda Report. This is an excellent opportunity to meet and participate in the NA service structure.

Now for the not-so-good news from our area: it became known at our October ASC that the now former chair person for our area office had misappropriated funds. Six thousand dollars was admitted as being misappropriated over a six year period. However, a through audit of the area office account was subsequently done and it was discovered that as much as \$19, 221 (nineteen thousand two hundred twenty one dollars) is actually missing.

However, because banking account documents had been inappropriately disposed of some time prior to the admission of the misappropriation of NA funds, it would cost us \$3400.00 to have the bank provide us with the necessary past banking statements. This was not seen as practical for our area. The addict in question did make a repayment plan and by the December 2011 ASC had paid back \$2000 of the money the addict had admitted to taking. In processing this event, we relied on suggestions found in World Service Bulletin #30 (which pertains to the theft of NA funds). At this point six options to resolve this have gone back to groups. Our groups will tell how they want this handled at the January 2012 ASC. As our area is struggling to learn from this and carry on, we have developed an ad hoc committee to review our area service policy and revise as needed.

At this point two things seemed to have slipped our attention over the years. One was the need to audit the area office account on a regular basis. This was not in policy so this was never done. Another problem that we allowed to happen is that we, as an area, did not respect the spirit of rotation and this addict had been in this position for 6 years. Our current ASC chair has long warned of the dangers of what she calls our "warm body syndrome" where we are just grateful to have a warm body in any position. This has now come, for lack of a better term, to bite us in the ass.

The geographic area served by the Miami Valley Area is Champaign, Darke, Greene, Logan, Miami and Shelby counties. Our area presently has 21 groups, 23 meetings, and 1 H&I panel. At our last Area Service Committee meeting, 16 groups were present.

In the past three months, one new group has started in our Area:

In the past three months, one group has folded (Spirit of Recovery).

Quarterly Donations and Expenses (to be reported each quarter)

Monthly expenses for the Miami Valley Area at our last ASC meeting were \$100.00. Donations from groups to the Area were \$152.77. We are making a donation in the amount of \$543.77 to the Ohio Region this quarter.

In the last quarter we received financial amends from two addicts who repaid a total of \$310.00 to our Area.

Annual Donations and Expenses (to be reported at the January RSC)

Total expenses for the Miami Valley Area for July 2010 to June 2011 were \$1222.18. The sum total of donations from groups to the Area in the same period was \$3811.26. The cumulative total of donations from the Miami Valley Area to the Ohio Region in that period was \$2589.08. The Miami Valley Area distributed approximately \$350 worth of NA literature to H&I efforts last year.

Literature Distribution

Our Area does not have a Service Office. We have a Literature Distribution Chair and Vice-Chair who sell literature to the Groups at the monthly ASC. Monthly literature sales to groups are \$250-\$350. We keep a specific inventory available and order from NAWS each to replenish stock. Special orders are included with the next monthly order and are available at the next ASC meeting.

Other Area Services (to be reported each quarter)

Presently all positions are filled except Vice-Chairperson, Vice-Treasurer, and RCM Alternate.

Website – Our Area has a website (mvascna.org) but there have been issues in keeping the posted information up to date. Knowing the value of accurate meeting information, we are concerned with the quality and effectiveness of the site. A lack of willing addicts with sufficient recovery and necessary skills are causing us to re-evaluate the expense. Also, much of the information (meeting schedule and event flyers) is also posted on the Ohio Region website, creating unnecessary duplication of efforts by trusted servants. We feel our Area's resources would better carry the message in some other way. We would still like to be able to post Area information such as ASC minutes, area guidelines and forms but are considering other ways to do so. Certainly, more will be revealed!

Area Service Structure (to be reported at the January RSC)

The Miami Valley Area of NA celebrated thirty years of service In the fall of 2011. Yay NA! Our area is not incorporated. ASC meetings are held monthly on the third Sunday each month at 2pm. We meet at Trinity Episcopal Church 60 South Dorset Road in Troy, Ohio.

Innovations and Challenges

In the past year we struggled to find addicts to fill service positions. Many addicts new to recovery (less than one year clean) were willing to take positions but almost all were unable to follow through with the service commitment. There

Committee Reports

RD/RCM Meeting:

The RD/RCM Meeting began at app. 3:30 pm with trusted servants & other NA members from 8 Areas in attendance. We began by reviewing and prioritizing a list of potential topics.

We had a rather lengthy discussion about the events that transpired at the U.S. Fellowship Assembly (USFA) that was held Oct. 28th-30th, 2011 in Tulsa, OK, and the recent announcement coming from the Gold Coast Area (in the South Florida Region) that (despite the discussion & consensus of those who attended the USFA in Tulsa) their area has decided to move forward with hosting the first United States Service Conference (USSC) on April 20th-22nd of this year. It was apparent that this latest development adds to the contentious nature of this "movement". Several members expressed their agreement with the potential benefit of having some form of national service entity, but added their concerns over how this "movement" has progressed. One RCM indicated that there will be a motion presented in new business this weekend that would seek to stop any further involvement of the Region with this "movement". (As of this point the Region has neither endorsed nor opposed the concept of forming a United States Service Conference (USSC) of Narcotics Anonymous or some other form of national service unit.) More will be revealed...

With regard to the Midwest Zonal Forum's Multi-Regional CAR/CAT Workshop that has been scheduled for February 10th-12th of next year, the RD reported that the Project Plan for this event had been posted on the Region's website (www.naohio.org) along with the event flyer. Until this last week, no further communication had been received from NAWS regarding the event. On Thursday we were informed who will be attending from the NA World Board to facilitate and we are still working to finalize an agenda for the event. We still need NA members to volunteer time to serve as greeters outside the workshop or help with refreshments in the hospitality area, and we are working out the details of what refreshments will be provided.

We then discussed Area plans for follow-up CAR/CAT Workshops. The Central Ohio Area has already made plans to facilitate a Workshop on February 25th at the "Just For Today" Club in Columbus, OH, and will seek to inform & invite neighboring Areas to attend & participate. The Five Rivers Area has already been talking with the Miami Valley Area about plans to facilitate a Workshop on March 10th in Bellbrook, OH, and will seek to involve the Dayton & Springfield Areas. (It was reported that the Dayton Area has already been conducting weekly CAR Review meetings in preparation for the CAR/CAT Workshop.) The Kentucky/Ohio Recovery Area RCM agreed to look into the possibility of a Workshop in their Area. The RD and/or RDA will attempt to communicate with members in the Finally Free Area about the possibility of a Workshop on February 18th (prior to AQUA) in Mansfield, OH, with the Northwest Ohio Area about the possibility of a Workshop on March 3rd in Lima, OH, and with the Greater Cincinnati Area & Hamilton/Middletown Areas about the possibility of a Workshop on either February 18th, March 3rd or March 17th in southwest Ohio.

One Area had asked for experience & guidance on the formation of Ad Hoc Committees. Several members present shared their experience with this process in their own Areas and at the Region.

The RD/RCM Meeting ended shortly before 6:00 pm. Thanks to all those who participated.
