A RESOLUTION OF THE GOVERNING BOARD OF THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT AUTHORIZING AN AMENDMENT TO CONTRACT NUMBER LS040998 WITH RU-MAR, INC. FOR CATTLE GRAZING AGRICULTURAL LEASE IN MARTIN COUNTY TO EXTEND THE TERM FOR FIFTY SEVEN (57) MONTHS, FROM DECEMBER 1, 2010 TO AUGUST 31, 2015, AND ADJUST THE ANNUAL RENT FROM \$34,829.88 TO \$48,700.00 BASED ON A RECENT APPRAISAL OF MARKET RENT AND INCREASED ACREAGE; PROVIDING AN EFFECTIVE DATE. (CONTRACT NUMBER LS040998-A03)

WHEREAS, the Governing Board of the South Florida Water Management 15 District deems it necessary, appropriate and in the public interest to authorize an 16 17 amendment to Contract Number LS040998 with Ru-Mar, Inc. for cattle grazing agricultural lease in Martin County to (i) extend the term for fifty-seven (57) months, from December 1, 18 2010 to August 31, 2015, (ii) add approximately 3,049.39 acres adjoining the leased 19 premises to allow flash grazing, (iii) adjust the annual rent from \$34,829.88 to \$48,700.00 20 based on a recent appraisal of the market rent and increased acreage, subject to an 21 annual adjustment based on the CPI or other appropriate commodity index, (iv) require the 22 lessee to pay the taxes and assessments accruing on the leased premises during the 23 lease term on or before February 1st or notify the District that it is contesting the tax 24 assessment, (v) revise the termination provisions to be consistent with current District 25 policy for agricultural leases, (vi) require the lessee to cooperate with the District to 26 optimize the existing infrastructure on the leased premises to maximize water storage on 27 the leased premises in conjunction with the Dispersed Water Management Program, (vii) 28 revise portions of the Statement of Work regarding the lessee's obligations relative to 29 prescribed burns and exotic plant management, and (viii) further revise the lease to be 30 consistent with the District's current standard agricultural lease; providing an effective date. 31 (Contract Number LS040998-A03) and: 32
