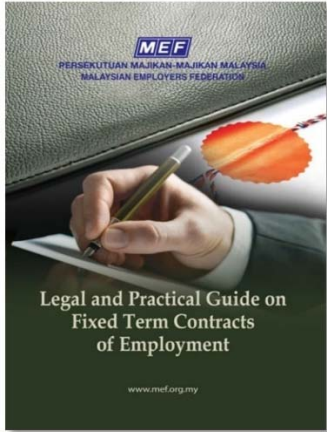


LEGAL & PRACTICAL GUIDE ON FIXED TERM CONTRACTS OF EMPLOYMENT
