# Sample Format:

## Notice of alleged Bylaw Violation complaint: Strata Property Act Section 135

#### Complaint, right to answer and notice of decision

135 (1) The strata corporation must not

(a) impose a fine against a person,

(b) require a person to pay the costs of remedying a contravention, or

(c) deny a person the use of a recreational facility for a contravention of a bylaw or rule unless the strata corporation has

(d) received a complaint about the contravention,

(e) given the owner or tenant the particulars of the complaint, in writing, and a reasonable opportunity to answer the complaint, including a hearing if requested by the owner or tenant, and (f) if the person is a tenant, given notice of the complaint to the person's landlord and to the owner.

(2) The strata corporation must, as soon as feasible, give notice in writing of a decision on a matter referred to in subsection (1) (a), (b) or (c) to the persons referred to in subsection (1) (e) and (f).

(3) Once a strata corporation has complied with this section in respect of a contravention of a bylaw or rule, it may impose a fine or other penalty for a continuing contravention of that bylaw or rule without further compliance with this section.

### Complaint against council member

136 (1) If a complaint is made about a council member contravening a bylaw or rule, the council member must not participate in a decision made under section 135 about the complaint.
(2) Subsection (1) does not apply if all the owners are on the council.

\* It is important to review your bylaws before you proceed with enforcement. Your bylaws may require a varying degree of penalties, fines or warnings prior to commencing action. In addition, the bylaws and penalties must comply with the Strata Property Act and Regulations.

## SAMPLE Notice of Complaint
