SAMPLE IRREVOCABLE LIFE INSURANCE TRUST FOR AN UNMARRIED PERSON WITH DESCENDANTS

Note: This form is a sample irrevocable life insurance trust that is designed to hold policy on the life of an unmarried person with descendants. The trust is designed to be GST tax exempt, but because of the hanging *Crummey* withdrawal rights may **not** qualify as a GST Trust (to which the grantor's GST tax exemption will be automatically allocated). Therefore, the transferor will need to annually allocate his or her GST tax exemption to contributions or will need to make a one time election on IRS Form 709 to have the trust be treated as a GST Trust (see, "GST Trust Election Statement" in Appendix 4). The trust contains a hanging *Crummey* right of withdrawal, and permits a donor to make gift contributions to the beneficiaries up to the annual exclusion amount. Optional and alternate language is contained in brackets { }.

This form is designed to be an adjunct to (and not a substitution for) the grantor's base estate plan, such as a revocable living trust. This form should not be used as a pour-over from a person's probate estate, will, or other trust.

Practice Note: Michigan practitioners should note that the sample forms complies with Michigan's Estates and Protected Individuals Code, which went into effect April 1, 2000.

As this is a sample form, practitioners must be careful when using the form to adapt it to comply with new developments in federal and state estate, gift and generation-skipping transfer tax law and to modify it to comply with applicable state law and the particular requirements and needs of their client; accordingly, the author makes no representations or warranties as to the efficacy of the form.
