# The first conference in France for the French childhood cancer survivors.

#### **Background**

On April 20th 2013, for the first time in France, health professionals and adults survivors from a childhood cancer met together around the medical, psychological and social questions they can experience throughout their life after the cure of a cancer

#### • Methods

This meeting is the result of an important research work led by the pediatric oncology department's of Gustave Roussy Institute, the INSERM, the National Institute of the Cancer and the Curie institute, who contacted by postal mail 2,500 former patients treated during their childhood between 1950 and 1985. This survey has triggered the creation of a clinic dedicated to these adults at Institute Gustave Roussy and Institute Curie.

To set up this meeting, the health professionals contacted the young Association "Les Aguerris ". This association was born last February by survivors from childhood cancer.

Members of the association worked with oncologists and a psychologist to set up the program of the conference.

### Results

This first conference was a real success : Seventy-five survivors with 28 accompanying people, 24 doctors or researchers attended the meeting. Besides setting the program, members of the associations played a major goal during the day by sharing their experience. Medical questions were discussed such as risk of fertility impairment but reassurance about the health of the offspring, need of cardiac follow-up after anthracyclines based chemotherapy or thorax irradiation, possible mellitus diabetes after abdominal irradiation. Insurance coverage, health insurance and French policy for investigations of late effects of treatment were also presented.

The strong need of a survivors association was definitely confirmed.

#### **Conclusions**

Many new subjects emerged during this first edition and since then, "The survivors" association has been working thoroughly with oncologists and other associations to promote their actions. A new date has already been decided; the second edition of the conference will take place on April, 5th 2014.
