### Rev. Robert E. Graves Died September 8, 2015 at age 79

Rev. Graves, pastor of Welcome Chapel Missionary Baptist Church in downtown Albany for 27 years, was appointed as a member of the CDSIF Advisory Committee in 2005. He assisted CDSIF in making connections with Albany area African-American faith communities, shared information on his mission trips to Africa, and helped us understand the components of an exemplary church program for seniors aging in place. Under his leadership, Welcome Chapel transported members to church and helped them with other transportation needs. He was ordained at Sweet Pilgrim Baptist Church before he was called to serve in 1988 as pastor of Welcome Chapel Missionary Baptist Church.

When Rev. Graves attended the 2013 Ceremony at which his devoted wife, Marian Graves, was saluted, he offered the benediction -- as he had done at the conclusion of at least four other Ceremony programs.

We give thanks for his life and service.

## Faith Communities Discuss Keeping Seniors Engaged & Connected

On July 22, 2015, 80 people gathered at Carondelet Hospitality Center in Latham for the Capital District Senior Issues Forum's annual program for faith communities. This year's program, again presented in partnership with the Albany Guardian Society, was entitled Faith Communities Keeping Seniors Connected and Engaged.

Participants began the day listening to reflections from The Rev. Susan Vincent-Cox, Minister of Discipleship & Mission, First Church in Albany, a member of the Reformed

Church in America. Rev. Vincent-Cox shared reflections from her ministry, her work as a counselor, and her experiences with the "Pilgrim's Walk" initiative in local senior living communities. Her insightful remarks set the stage well for the day.

Next participants heard representatives from various faith based programs and communities speaking on the topics of "Connecting Seniors" and "Engaging Seniors." Among the panel programs described in the first panel were St Peter's Health partners faith community nursing, Capital Area Council of Churches "Seniors on the Go," FOCUS churches volunteer programs, and Pilgrim's Walk. Participants in the second panel described the Eddy Senior Care Team program of St Edward's Parish, the ways a New Lebanon Roman Catholic parish keeps rural seniors engaged, the Senior Shepherds Program of Good Shepherd Lutheran Church, and the social justice programs of Temple Beth Emeth.

More than half of the participants stayed for the afternoon session which offered them an opportunity to engage with each of the presenters to learn more about the programs. Thanks to the speakers, the Albany Guardian Society and the participants...another successful and meaningful program of the Forum.

### **Keeping Seniors Engaged in Life of a Parish or Congregation**

A sense of purpose and meaning in one's life is a

driving force in the desire to keep on living. According to a Canadian publication, "It stands to reason ...that seniors and those who are concerned with seniors' well-being should recognize that the subjective dimension of 'meaning' is as important as the material and social conditions of their lives. What gives life meaning varies from person to person: human relationships, work, individual goals and social causes are typical sources of meaning..." (taken from "Expression" at http://publications.gc.ca/collections/Collection/H71-

4-1-8-4E.pdf)

In addition, cardiologist, Dr. Randy Cohen, recently reported his findings in a study that involved 137,000 older people, in which he observed the effects of purpose and meaning in life on the physical health of the elderly. He said, "Purpose in life is considered a basic psychological need, and has been defined as a sense of meaning and direction in one's life, that gives the feeling that life is worth living." As people become less able to engage in physical and/or mental activities, they eventually retreat from religious and social gatherings, often leading to increased social isolation. Without that on-going social connection and a feeling of being needed, their sense of having a meaningful existence may significantly decline. People may think of themselves as no longer having value in their surroundings as they become less able to "do things."

Faith communities do have opportunities to re-kindle a sense of purpose and meaning for those who are no longer able to sit in the pews, or to help with church suppers. The first 2016 issue of this newsletter will present some hands-on ideas for bringing homebound people back into a circle of purposeful activity. ### Now Compare Health Care Provider Quality! Who Knew?

Until recently it has been very difficult for anyone to obtain information about the quality of medical care. We can find more reliable comparative information to purchase a new car than when we seek costly health care.

The federal government has been using special surveys and other data sources to compile comparative information available online about service quality and the capacity for health care providers funded through Medicare.

Type in your zip code to find providers in your area and compare up to 3 providers at a time based on several key indicators of quality. For example, you can compare consumer satisfaction regarding communication with doctors or nurses in hospitals or time spent waiting in emergency rooms. You can obtain copies of quality inspections (surveys) done of nursing homes and learn about any adverse findings or penalties.

The government now provides a 5 STAR rating system for nursing homes, hospitals, home health agencies and dialysis centers to help persons

in need or their families assess the quality of a potential nursing home. The New York State Department of Health also maintains a website for all doctors to show information about their training and any adverse findings.

NYS State Is Considering Folding the Office for the Aging into an Office of Community Living

By December 31, the New York State Office for the Aging (NYSOFA) must provide the Governor with a feasibility study for folding NYSOFA into a new Office of Community Living. The new Office would include programs for the aging and disabled persons of all ages including persons with disabilities in vision, hearing, mental health, movement, thinking, remembering, learning, communicating and social relationships.

New York leads the nation as one of the first states to establish an Office for the Aging. Since 1965, NYSOFA has served as the governor's recognizable advocate for aging with a mission to help older persons remain independent for as long as possible. The agency helps guide policy development to improve the quality of life of older New Yorkers and oversees the implementation of programs funded through the Older Americans Act and New York State Elder Law. The Office also oversees services provided locally through a network of 59 local offices for the aging and hundreds of community based providers.

This is not the first time the State of proposed merging the State Office for the Aging into another agency. The most recent proposal came through the Governor's SAGE Commission which abandoned the idea after considering input. The latest new proposal was generated through legislation supported by the adult disabled provider community. Aging advocates have noted that it took decades to establish and advocate for the aging within state government. This is a critical time for those who want their voices to be heard.
