**Coming I-55 South:**

Take Madison Exit. Go right off ramp onto Hwy 463. At second red light take a left onto Highland Colony Parkway. You will go through one red light and two four-way stop signs. After the second stop sign, go approximately 1 mile. 600 Concourse Building is on the left. Park in the back of the building. MHCA meeting area is the first door to the right after you enter the building. There will be signs posted. Please note: the sign for 600 Concourse Building is low to the ground. The building right past 600 Concourse Building has "Bank Plus" on the upper part of the building. You turn immediately in front of this building. MHCA Office is the first door to the left as you enter the building.

**Coming I-55 North:**

Take the second Old Agency Road Exit. You will loop around and cross back over the interstate. As you approach the roundabout veer to the right onto Highland Colony Parkway. You will go through 4 red lights. After the fourth red light 600 Concourse Building will be on your right. Park in the back of the building. MHCA Office is the first door to the left as you enter the building.
