# Registration Instructions

## INTERNET REGISTRATION

### (QUICKEST AND EASIEST Method of Registration!!)

(credit/debit card payments only)

- ❖ Visit our website at: [www.drive.nsc.org](http://www.drive.nsc.org)
- ❖ Website provides a full up-to-date schedule of classes and answers to frequently asked questions
  - **Guarantee a seat in your preferred class in seconds!**
  - **Avoid hold time on phone!**
- ❖ Verification of your successful registration will be sent to you via e-mail within 1-3 business days (often within minutes)

## TELEPHONE REGISTRATION

(credit/debit card payments only)

- ❖ Telephone registrations should be made at least two weeks prior to the date of the class (based on availability)
- ❖ Please provide the representative with the date(s) & location of the class you wish to attend. Please have your driver's license number and credit card ready for processing.
- ❖ OFFICE HOURS: Monday – Friday: 8:30am-4:45pm EST Saturday: 8:00am-12:00pm EST

## MAIL REGISTRATION

- ❖ Pay by money order, personal check, certified check, Visa, MasterCard, AMEX, or Discover.
  - If you choose to submit a personal check as payment, you will be scheduled for a class 18 days from the date we receive your check. There will be a \$25.00 service charge on all returned checks.
- ❖ Make checks or money orders payable to: **NATIONAL SAFETY COUNCIL**
- ❖ If registering for the SCARR class, **you must write a short paragraph explaining the violation(s) that resulted in your having to attend this class and submit it with your registration form and payment.** The paragraph must include the following information:
  - What your speed was
  - The speed limit
  - Location of the violation

### What if I am unable to attend the class as scheduled?

If you are unable to attend the class as scheduled, you must notify our at least office 48-hours prior to the date of the scheduled class to avoid a rescheduling fee by calling (800) 398-0328.

There will be a \$40.00 rescheduling fee charged to anyone who does not attend the class as scheduled, fails to bring the required confirmation, and/or identification, or arrives after the class has begun. The rescheduling fee must be prepaid.
