CREDIT BY EXAMINATION
FACT SHEET
ALEA (Arizona Law Enforcement Academy)**

Rio Salado College, a Maricopa County Community College in Tempe, Arizona, is proud to announce its Credit by Examination program in Law Enforcement Technology. This program is for individuals who are interested in attempting to receive college credit for learning acquired, demonstrated, and assessed at the Arizona Law Enforcement Academy.

Eligibility:

- Graduated from the Arizona Law Enforcement Academy since September 1, 1990.

Policies:

- Students may attempt to earn 39 credits through the Credit by Examination process and apply them toward the requirements for the Law Enforcement Technology Degree program.
- These 39 credits constitute the required courses needed for the Certificate of Completion in Law Enforcement Technology. These credits constitute 39 of the 64 credits needed for an Associate of Applied Science (A.A.S) Degree in Law Enforcement Technology.
- By signing the enclosed Credit by Examination application, students are authorizing the Arizona Law Enforcement Academy to release grading information to Rio Salado. Courses will be graded on both a letter grade “A, B, or C” and passing grade “P” basis. A grade of “P” is equivalent to a “C” or better and is not computed in a student’s grade point average.
- The fee is \$42.00 per credit hour, and is not refundable after the evaluation process has been conducted. The fee for all 39 LET credits is \$1638.00 (refer to back for listing of classes).
- Credit earned through Credit by Examination is transferable to other colleges and universities at their discretion. It is strongly recommended that students check with their local college or university regarding credit transferability prior to applying.
- Allow 4-6 weeks for processing. Upon receipt of application, Rio Salado will contact the Arizona Law Enforcement Academy for written verification of academy and licensing exam completion and grades.
