RULES AND REGULATIONS

GENERAL RULES

- A. Open to all farm tractors, wheel or track.
- B. All minors must have written consent of parents or guardians to enter the contest.
- C. Judges and drivers meeting will be at 12:00pm at pull site. All drivers must attend.
- D. Sublimity Harvest Festival reserves the right to accept or reject any or all entries.
- E. Only one person allowed on tractor upon entering track area.

WEIGH-IN RULES

- Time: Sun. 8:00am 11:00am at pull site.
- Weight includes driver. No weights changed, weight shifting, or driver changes after weigh-in.
- All weights are secured.
- Tire pressure 10psi on all dual 4-wheel drive tractors during the weigh-in. Pressure may be adjusted after weigh-in, but the weight must remain the same.
- Tractors may be subject to random re-weigh.

 Draw bar height maximum 21 inches from ground to top of draw bar. Tractor must pull from plow draw bar with no hitches closer than 12 inches to center of axle. Box tubing not allowed.

PULLING RULES

- A. Once pull has started, no down-shifting is allowed. Up shifting is allowed on the go only.
- B. Pull is ended when tractor engine stalls or forward motion stops. No jerking or hole digging allowed.
- C. Drivers must remain seated.
- D. Driver is disqualified if any part of tractor or sled crosses the white line.
- E. Contest to be governed by a panel of judges with all decisions final. Judges have the right to stop and disqualify any contestant's tractor if it is being operated in such a manner as would be considered unsafe.
- F. Maximum speed not to exceed 5 mph
- G. Tractors will only be allowed to pull one time in two classes.
- H. Draw bar must be securely attached to tractor.
- I. No shaved or cut tires are allowed.

IN CONSIDERATION of being permitted to enter for any purpose, any RESTRICTED AREA (herein defined but not limited to the racing surface, pit areas, in field, burn out area, approach area, shut down area, and all walkways, concessions, and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, work for, or for any purpose participate in the event. EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin, acknowledge, agrees, and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgment that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe he will immediately advise the officials of such and will leave the restricted areas:

- 1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releases", from all liability to the undersigned, his personal representatives, assigns heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participating in the event;
- 2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.
- 3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releases or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad as is permitted by law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducements apart from the foregoing written agreement have been made.
