



# **Area to Review**

Consider each of these important areas, and review their applicability to you as you approach your full-retirement age 60 or earlier eligible retirement age. (If you served on active duty contingency operation orders since Jan. 28, 2008, your retirement age is reduced three months for every 90 days served, down to age 50.) Keep this checklist available to check off each item as you complete it. Make notes including the date on which you called and any follow-up requirements. Address each item on the list as you approach this important transition.

- Notice of Eligibility for Retired Pay/(20-year letter) 90-day stamp for Survivor Benefit Plan (SBP) election
- SBP election options

Option A — delayed decision until age 60

Option B — delayed annuity

Option C — immediate annuity

# **Application for Retired Pay**

You should receive a retirement package from your service with the Application for Retired Pay form. Contact your service immediately if you do not receive this form in the time frame noted.

In addition to the Application for Retired Pay form, you will need to complete the following forms, which should be included in your retirement package.

- DD Form 2656 Instructions, June 2008 (data for payment of retired personnel)
- Standard Form 1199A (direct deposit sign-up form)
- IRS Form W-4 (employee's withholding allowance certificate)
- Chronological Statement of Retirement Points/Annual Point Capture
  (Review for accuracy. If incorrect, attach copies of Leave & Earnings Statements to prove additional points earned.)
- Records (to obtain and copy)
  - DD Form 214
  - service records
  - medical/dental records for servicemember and dependents
