Applicant Instructions:

Complete one form for each person you listed in Question #36. All of the character references listed must have known you for at least two years. (You may not use the names of anyone identified in your answers to Questions 12, 13, and 14.) Do not include any family members, in-laws, fiancé/fiancée, significant other, or anticipated future family members.

The forms must be sent directly to the Board by the character reference. Facsimile or e-mail transmissions are not acceptable.

Follow these instructions to complete the form:

- 1. Check the appropriate box indicating how you are applying for admission: Diploma Privilege, Wisconsin Bar Examination or Proof of Practice Elsewhere. Failure to check the appropriate box may lead to delays.
- 2. Type your name on the "Applicant Name" line. This name must match question #1(a) of the Applicant Questionnaire and Affidavit.
- 3. Type any additional names you have been known by, other than the name you listed on the "Applicant Name" line, in the "Also Known As" line. Names must match question #1(b) of the Applicant Questionnaire and Affidavit.
- 4. Type the name of the character reference in the "Reference Name" line.
- 5. Type the address of the character reference in the "Street Address" area and the "City, State, Zip code" area.
- 6. Do not write on the rest of the form.
- 7. Mail the form <u>along with these instructions</u> to each reference with a stamped envelope addressed to the Supreme Court of Wisconsin Board of Bar Examiners at the address listed above.
