To apply for a second passport, please complete the following forms:

- 1- Complete Form DS82 Passport Renewal Form online, print and sign it. There is a direct link to this form on our website http://atlaspvs.com/forms.asp OR, here is a direct link to the DOS and the form DS82 https://pptform.state.gov/
- **2-** Complete the following two forms for the second passport request. (*Input information on form below*),
- **3-** Complete TWO (2) Authorization Forms (Input information on form below),
- **4-** You must also submit your original current valid passport,
- **5-** Prepare and submit an original signed letter on your company letterhead (*input information on sample letter below*),
- **6-** The same passport renewal Federal fees of \$170 applies to second passport request,
- 7- Include two recently taken passport type, passport size (2 x 2") photos,
- **8-** Send all the above to Atlas for further processing.
