When you are approved for a property you must sign your lease within 48 hours of your approval or you may lose your priority position and the owner may have us process any back-up applications.

At your lease signing, you will need to bring a cashiers check or money order (NO CASH or personal checks) for the Security Deposit plus the rent or prorated rent amount payable to Southern California Real Estate Management, Inc. or S.C.R.E.M. Inc.

Property Showing Policy & Application Processing Procedures

- The properties we show are currently for rent or lease.
- We continue to show a property until a rental agreement/lease is executed.
- Once an applicant is approved we will inform any other applicants and anyone with an appointment to see that property or who inquires about that property, that we have an "Approved Applicant".
- You may submit an application as a back up in case an approved applicant withdraws or an application is in process. We
