

Commercial Invoice Instructions

The Commercial Invoice is important for the clearance process used by customs officials to classify merchandise so that duties & taxes can be correctly assessed. The sample Commercial Invoice shown below is a generic form. Please note that Customs authorities reserve the right to require additional documents and information. *The Commercial Invoice should be printed on your company's letterhead.*

1. Shipper/Exporter:

Provide contact name, company name, and full address.

2. Country of Manufacture:

The country in which each of the commodities in your shipment was originally manufactured or produced.

3. Importer:

If the shipment will be handled by an importer who is not the recipient, add the full name and address here.

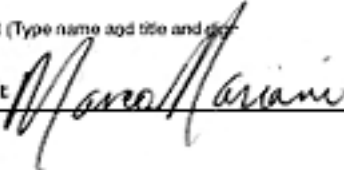
