<b>Survivor Benefit Program (SBP) Briefing</b>		
Active Duty SPB remains in effect—Retiree is not eligible for Reserve SBP		
<b>Promotion Briefing</b>		
a. If member is promoted while in the Reserves, may elect Reserve retirement pay at the higher grade upon reaching age 60		
b. If member is not promoted while in Reserves, may request recomputation of retired pay to include Reserve participation		
<b>Retirement Pay Briefing</b>		
a. Member will continue to draw retirement pay, but will not receive dual compensation for AD retirement and Reserve participation—		
b. Member will receive reduced AD retirement pay by 1/30 <sup>th</sup> for each day member performs Reserve paid participation or may elect to participate for points only.		
c. Member must complete section II and III of AF Form 1962, Election of Reserve Pay and Allowances or Benefits from Prior Military Service, and submit it to their Reserve Pay Office for initial selection and for any desired change in selection.
