 - o Indicate the GST reporting method used (quick/regular)
 - Summary and/or receipts of income and operating expenses for the year (NOTE- if registered for GST/HST,
 - amounts on your summary include or exclude GST/HST)
- Details of any capital asset additions or dispositions during the year
- · Details of vehicle expenses if you use it for business purposes
- · Details of home office expenses if you use it primarily for business purposes
