### FOOTNOTES FOR 2013 DUE DATE CALENDAR

- Dates in black circles designate Freddie Mac 2013 holidays. Offices will be closed on these days.
- Dates in green squares designate Federal Reserve Bank holidays. No principal or interest will be accepted or posted on these days.
- Dates in blue circles designate the 44th calendar day prior to a balloon maturity date.
- Dates in light blue squares designate dates by which you must transmit modifications for settlement via Workout Prospector® and submit Form 1128, *Loss Mitigation Transmittal Worksheet*.
- Dates in purple circles designate the last day on which Freddie Mac processes modifications for the accounting cutoff.
- Dates in light green outline diamonds designate the last day to report or correct loan-level transactions for the most recent accounting cutoff. Liquidations must be processed by this date to receive credit on the *Detailed Adjustment Report* for the most recent accounting cutoff.

\* Please report prior to 5:00 p.m. Eastern time on the due date.

\* Freddie Mac must have funds available by the remittance due date. You must complete your remittance no later than 9:00 p.m. Eastern time on the business day prior to the remittance due date.

All reporting and remitting dates represent the last date for reports/remittances to be received without incurring late fees. Reporting/remitting windows exist prior to these due dates. Please refer to the back of this calendar for more information.
