

# Model Release Form: Paid Photographic Session

THIS MODEL AGREEMENT AND RELEASE ("Agreement"), as dated below, is between the undersigned photographer ("Photographer") and the undersigned model/performer ("I", "me", "myself"). The agreement is as follows:

## Verification of Age and Capacity

I verify that I am of legal age of majority (>18 years) at the time that these photographs are taken. I further verify that I have full legal capacity to execute this authorization without the consent or knowledge of any other person. I understand that I will be required to present proof of identity and age at the time of the photographic session.

## Photographic Release

I hereby grant the undersigned Photographer permission to photograph me. I further give my irrevocable consent to the Photographer and his direct or indirect licensees and assignees to publish, republish, reproduce, distribute, or otherwise transmit the images of myself in any medium for all purposes, commercial or non-commercial, throughout the world. I understand that the images may be altered or modified in any manner. I hereby waive any right that I may have to inspect and approve a finished product or the copy that may be used in connection with an image that the Photographer has taken of me, or the use to which it may be applied. I further release the Photographer and his direct or indirect licensees and assignees, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the use of these images.

## Terms for Paid Photo Session

I verify that I have entered into a Paid agreement with the photographer. I understand that this means that I will be financially compensated for my professional services rendered during this photographic session. I may also be financially compensated for reasonable travel expenses incurred solely for travel to and from this photo shoot. The complete and total financial compensation package has been agreed upon by both parties and is as follows:

I understand that this represents a one-time payment. Upon receipt, I waive all rights to additional payment or remuneration for my services rendered during this session, and I relinquish any right to compensation, financial or otherwise, from any future use of the images (or their derivatives) produced during this session. I understand that full copyright for all images produced during this session is retained solely and exclusively by the Photographer and that, by accepting payment, I have waived my rights to any present or future possession, personal or portfolio use, or commercial application of these images.

## 18 USC 2257 Compliance Statement

I understand that the photographs taken as a part of this session may contain material that is considered in some locations and/or by some jurisdictions to be adult in nature and/or to contain adult content. I verify that I am of legal age to consent for being the subject of such images, and I understand that there are potentially serious legal consequences to providing false statements or documentation of my age. I understand that copyright for these images is retained by the Photographer and that these photographs may be used for personal, portfolio, and/or commercial applications (including sale and/or distribution). I hereby release all claims against the Photographer and his direct or indirect licensees and assignees for any claims for remuneration associated with production, possession, sale, distribution, or any other use of such photographs.

### Other Terms

I understand that I have the right to have one chaperone present during the photographic session and that if I waive this right I do so of my own will, thereby absolving the photographer of any legal consequences or remuneration that may be associated with the absence of a chaperone.

I understand that a combination of still or real-time, audio, image, and /or video recording may be in use during this photographic session. This is primarily intended for safety and security purposes, although the use of such recording is not necessarily limited thereto. I hereby agree to be recorded by such devices in said modalities during the entirety of this session. Furthermore, I waive any right that I may have to such recordings and relinquish their ownership and full copyright to the photographer. I further release the Photographer and his direct or indirect licensees and assignees from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the use of these recordings.

I understand that it is my obligation to arrive at the agreed upon location by the agreed upon time and to participate in the photo shoot for the agreed upon period of time. I understand that violating any of these terms invalidates my claim to any form of monetary compensation for this shoot and/or any photographs that I was previously entitled to receive. I further understand that violation of these terms may result in additional financial costs to me associated with lost investments of the Photographer's time and/or resources and that I may be held legally liable for these charges.
